#### Time to ask Hospital Board questions

To the editor

I read with interest the feature concerning the financial problems of Pioneer Memorial Hospital.

Perhaps it is time to ask the hospital board and administrator some questions in your newspaper since I wrote them several letters last fall and they didn't even have the courtesy to answer them, either by mail or telephone.

1. Why doesn't the hospital have a doctor on their board of directors? Mr. Ochsner stated, "It is important to remember that the Board and

I are very concerned about meeting the needs of the community. Surely a doctor on the board, with medical input as to the needs of the people in the community, would be an asset

2. If the food is as good as a couple of people have stated, why do patients have to take antacids after every meal?

How many members of the County Court have gone to the hospital for lunch (without prior notice they were coming?)

Why was I admitted to the hospital by the doctor on-call and then have him refuse to turn my case over to our family doctor when he returned?

I came home from the hospital after three days, in worse shape than when I was admitted, with no diagnosis made as to the reason I was initially admitted.

The feature also says there is a decreased use of the ancillary or support services such as the lab and radiology. My daughter had a blood test in the hospital lab and it took much longer than necessary because the plastic tube used to hold the blood was cracked and there wasn't sufficient suction to draw the blood. Is this quality service?

Why do some of the nurses refuse to take orders for patients from a member of the doctor's office and say they will only take direct orders from a doctor?

5. An EMT group would be great but first, the ambulance should be ready at all times to eliminate a re-occurance of arriving at a scene only to find someone had failed to put the stretcher back in after the previous run

"The most obvious solution to the lack of use is to bring in another physician into the community. How is another doctore going to solve the problem when the hospital couldn't even support the two doctors they now have if it wasn't for their private practices?

If Pioneer Memorial Hospital is going to survive, buckpassing needs

to stop. Several people have told me they feel the same way my family feels; the only way they will use the facilities of this hospital is in a dire emergency. Then it would be just to become stabilized and transported to another hospital.

Heppner needs Pioneer Memorial Hospital but not in it's present Possibly the County condition. Court should check into the existing conditions. Make some drastic changes and give the doctors who are currently practicing in Heppner more input into the way the hospital

Maybe a poll should be taken to find out what the people in the community expect in a hospital. What changes they would like to have and whether they now utilize the hospital. If the answer is negative, why don't they use these

services? With everyone working together; the community, the hospital board, the doctors and the County Court, Pioneer Memorial Hospital could become self-supporting and a facility the people in Heppner can be proud of
