

# Iraq targets for flour export

#### program

Secretary of Agriculture John R. Block today announced that a wheat flour offer to Iraq will be the twelfth initiative under the U.S. Department of Agriculture's Export Enhancement Program. As with previous announcements under this program, sales will be made at competitive world prices

Block said this program will give U.S. exports the opportunity to sell up to 150,000 metric tons of wheat flour, including a Commodity Credit Corporation bonus in the form of wheat to be provided to U.S. exporters from CCC stocks. The CCC bonus will enable U.S. exporters to compete at commercial prices in the Iraqi market.
