**NOTICE OF HEARING**  
THE MORROW COUNTY COURT HAS BEEN PRESENTED WITH A PETITION FOR FORMATION OF A PARK DISTRICT KNOWN AS THE "WILLOW CREEK PARK DISTRICT." The proposed park district shall consist of the whole of Morrow County, with the exception of the existing Boardman and Irrigon precincts. The purpose of the proposed district is to develop and maintain recreational facilities around the Willow Creek Dam and Lake area. Other recreational projects may be undertaken by the district. The Ronald McDonald house in Portland is seeking donations in order to continue its operation.

Families with children from birth to age 18 are sometimes referred to the Ronald McDonald House by health care professionals while their child is receiving treatment at Portland area hospitals. Families pay \$10 a night which is used to offset the cost of operating the house. No one, however, is denied use of the facility because they are unable to pay. The house is intended for the short term use, up to 30 consecutive days.

No medical treatment or counseling is available at the house, and there is no affiliation with any religious order or sect. Nine families from Morrow County have used the facility at some time since it opened in 1974.
