Notice of Call for Chemical Bids: Specifications and Bid Procedures Notice is hereby given: That until October 22, 1986 at 10:00 a.m. in the SWCD office, Heppner, Oregon, the Morrow SWCD Board will receive bids for the following chemicals:

50 gallons of chemical under the manufactured name of Tordon 22K Weed Killer, packaged in 5 gallon or 2 1/2 gallon containers.
60 gallons of 2, 4-D LV6, packaged in 5 gallon containers.
10 gallons of Activator 90 or similar product packaged in 5 gallon cont. Material Safety Data Sheets

(MSDS) must be attached to bids on all chemicals that are being bid. Indicate in the bid if you will provide additional chemical at the same price during the 1987 spraying season. Delivery to be made at the old bus sheds in Heppner, Oregon no later than November 5, 1986. All bidders will be notified following the bid opening as to award of bid. The Morrow SWCD reserves the right to waive any formalities and to reject any or all or part of the bids received. If total payment is larger than available funds, payment will be split within the 1986-87 year budgets.
