BOARDMAN PARK AND RECREATION DISTRICT GENERAL OBLIGATION BOND AUTHORIZATION

SHOULD THE DISTRICT BE AUTHORIZED TO CONTRACT A GENERAL OBLIGATION BONDED
AMOUNT NOT TO EXCEED \$100,000? IF THE BONDS ARE APPROVED, THEY
WILL BE PAID BY TAXES ON PROPERTY OR PROPERTY OWNERSHIP THAT ARE NOT SUBJECT
TO ARTICLE XIb, ARTICLE XI OF THE OREGON CONSTITUTION.

SHOULD THE DISTRICT BE AUTHORIZED TO CONTRACT A GENERAL OBLIGATION BONDED
AMOUNT NOT TO EXCEED \$100,000. BOND PROCEEDS TO PROVIDE FUNDS FOR PARK IMPROVEMENTS INCLUDING, BUT NOT
LIMITED TO, IRRIGATION IMPROVEMENTS. THE BONDS WILL MATURE OVER A
PERIOD OF TEN (10) YEARS.
