Tartar-Control Toothpastes

Dental experts indicate that there are two primary causes of tooth loss in adults 35 years of age and older. One cause is gum (periodontal) disease and the other is tooth decay (dental caries). Much of the dental education directed at the public is targeted toward the prevention of gum disease and tooth decay. One of the major factors in the development of both conditions is the presence of plaque on the gums and teeth.

Dental plaque is sticky, colorless film of bacteria that is constantly forming in the mouth. After a meal that is especially high in sugar, plaque begins to form. If plaque is not removed within a reasonable period of time through brushing and the use of dental floss, it tends to harden into a material that is called calculus or "tartar." Tartar is difficult to remove and often requires the services of a dental hygienist or dentist. Tartarcontrol toothpastes are promoted as products that slow the rate at which plaque is converted into the harder tartar material.

Tartar-control toothpastes include zinc chloride or various pyrophosphates as active ingredients. In one recent study of a toothpaste containing both ingredients, individuals were told to brush their teeth twice daily. Results indicated that the formation of tartar was reduced by as much as 38 percent. One person in the study experienced slight gum irritation.

PUBLIC NOTICE

A Public Meeting will be held at 7:30 p.m. September 14, 1992 at the Heppner City Hall for the purpose of presenting information regarding proposed improvements to the City of Heppner Wastewater Treatment and Disposal Facilities. During the meeting, questions and comments will be received from the public.

In 1989, the Heppner City Council approved a Wastewater Facilities Plan that identified deficiencies in the City's wastewater treatment system, and presented alternatives for making improvements. The City Council selected a plan to improve the existing Wastewater Treatment Plant and to construct a spray irrigation system for summer effluent disposal that would meet requirements of the U.S. Environmental Protection Agency and the Oregon Department of Environmental Quality. The voters in the City of Heppner approved a \$625,000 general obligation bond and the EPA awarded the City a grant for the remainder of the project costs.

Since completion of the original Watewater Facilities Plan, a number of obstacles have risen during a two-year long effort by the City to site a spray irrigation facility and a storage pond, including land use laws and regulations, floodplain regulations, lack of suitable sites, and landowner concerns. From the struggle to find an acceptable effluent disposal alternative, a new promising alternative has emerged that will meet the requirements of the Oregon Department of Environmental Quality and the Oregon Department of Fish and Wildlife. This new "Split-Flow" Alternative will still include rehabilitation and upgrade of the existing treatment plant as originally planned, but will also include the summertime irrigation of treated and disinfected effluent on the Willow Creek Golf Course and nine acres adjacent farm land and nine acres of adjacent farm land with a limited amount of effluent to be discharged into Willow Creek. During winter months all of the treated and disinfected effluent will be discharged into

Willow Creek.

Since the "Split-Flow" Alternative was not evaluated during the original facilities plan process, an amendment has been prepared as required by the DEQ and the EPA to be sure the proposed new "Split-Flow" effluent disposal plan is cost-effective and environmentally sound. A copy of the Facilities Plan Amendment is available at City Hall for review by interested persons during the hours of 8:00 a.m. to 5:00 p.m. weekdays.

The "Split-Flow" effluent disposal alternative will be discussed at the public meeting at 7:30 p.m. September 14, 1992. Interested persons are encouraged to attend. Questions and comments will be welcome. Following the public meeting the City Council will consider final approval of the "Split-Flow" Alternative and the Facilities Plan Amendment.
