Body recovered from river

The body of Toby Leroy Moore, 33, Hermiston, was located in the Columbia River north of the Irrigon fish hatchery around 5:45 p.m. on Saturday, August 20, according to the Morrow County Sheriff's Office.

Moore drowned in the Columbia around 5:50 p.m. Aug. 14, but divers from Columbia Basin Dive and Rescue out of Kennewick were unable to locate the body in subsequent

searches.

According to Morrow County Sheriff Roy Drago, Moore had been lying on an air mattress in the river when he decided to get into the water. When he did so, the air mattress blew away and Moore was unable to get back to shore, said Drago.

The body was recovered by Columbia Basin Dive and Rescue personnel and the Morrow County Sheriff's Office.
