### Measure 38 a dangerous process

To the Editor:

As a family physician who opposes Measure 38, I was surprised to find an argument in favor of that measure entitled "Family Doctors Support Measure 38..." in my Voter's Pamphlet.

When I looked up the doctors who signed that argument in my American Board of Family Practice Directory, I found that only one of the six was listed.

It is bothersome that six physicians would misrepresent themselves as speaking for family doctors, when most of them are not certified in that specialty. It is, however, in keeping with Measure 38 itself, which misrepresents itself as being for clean water, when it is in fact against ranching.

The basic premise of the measure, that cattle are necessarily bad for stream quality, is faulty. One need only look at the fall issue of Range magazine to find examples, in Oregon, of cattle being used to

restore riparian areas. Also faulty is the measure's focus on cattle and exclusion of other known sources of stream contamination. The proponents of Measure 38 discuss cattle as a source of Giardia, but leave out that this organism is commonly called "beaver fever," which suggests another source.

Portland has a sewer system that combines sewage and rain runoff and dumps the mix, untreated, into the Willamette River when overloaded. The worst case of illness from drinking surface water that I have cared for, was in someone who fell into the Willamette and got a few mouthfuls of that river's

Measure 38 does not address these or other sources of water pollution. It is not really for clean streams, just against livestock.

The biggest reason to vote against Measure 38, however, has nothing to do with cows or water. All Oregonians should treats ranchers. Rather than promote a cooperative approach to water quality, the measure imposes a "zero tolerance" on one user group, while not requiring anything of the other user groups.

No one has asked the people of Portland to stop using their toilets, bathtubs and storm drains until their sewer system is fixed. It is no less unreasonable or disruptive to the lives of ranchers to demand that no livestock ever be allowed near a stream.

Even worse than the targeting of one group is the language of Measure 38 that encourages lawsuits against that group. The measure specifies that "Any person may commence a civil action..." and limits the ability of the court to award costs to the person being sued, even if they win the

If this measure passes, the proliferation of lawsuits will not just affect the ranchers. Extra lawsuits will place additional demands on our legal system, which will affect all of us. Other measures may target other groups. Complicated issues such as water or air quality will become more difficult to solve cooperatively as lawsuits replace dialogue, and we will all suffer for that.

In sum, Measure 38 is a dangerous process, based on a faulty premise, focusing on only one aspect of a complicated issue. I urge all Oregonians to vote "no" on Measure 38.
