

### Sheriff's Report

The Morrow County Sheriff's office reports dispatching the following business during the past week:

Nov. 26: Morrow County deputy responded to a report of a driver doing paperwork and driving "all over the road" on I-84 eastbound from milepost 142. The deputy followed the driver from Boardman to Hwy. 730, all was all right;

Morrow County deputy responded to a report of carpet taken from three rooms in a mobile home at Sunridge Homes in Irrigon and that several doors were damaged on mobile homes;

Heppner Police Dept. investigated a report of four juveniles who appeared to be drinking behind the Heppner Library. Andy Burt, Heppner, was cited for Mino: in Possession and released;
