

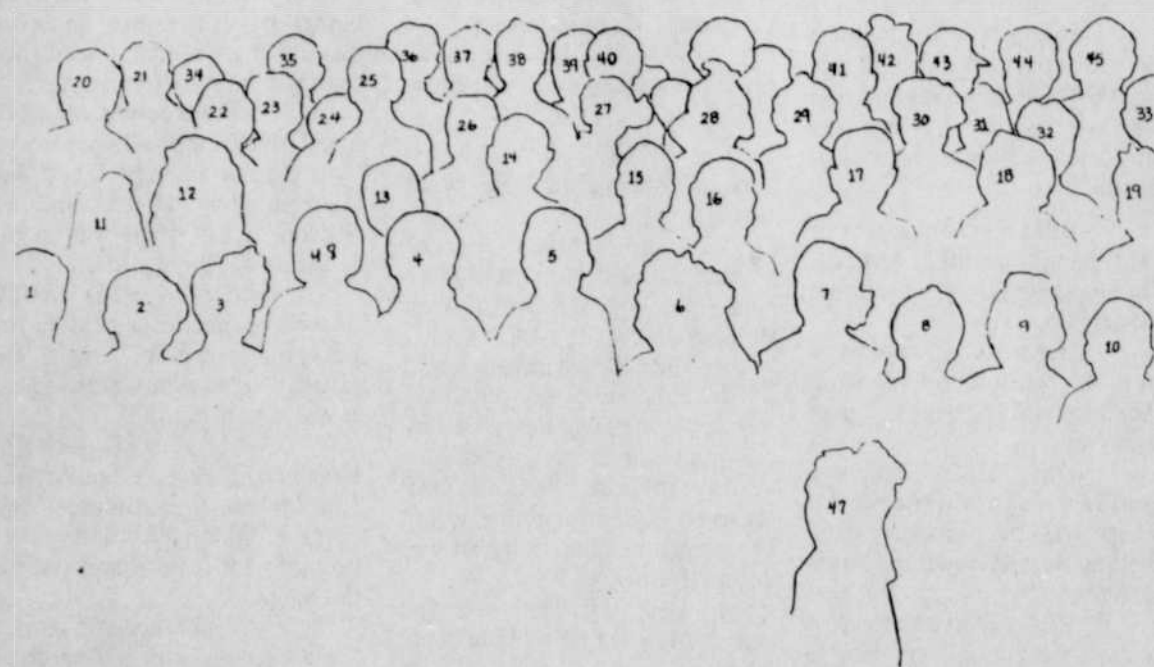


Can you identify any of these children?

(Threemile Farms, LLC Project) PUBLIC NOTICE IS HEREBY GIVEN, that on September 13, 2000, the Board of Commissioners (the "Board") of the Port of Morrow, Oregon (the "Port") will hold a regular meeting commencing at approximately 1:30 p.m. The public meeting will be held at the regular meeting place of the Board, at the offices of the Port, located at Two Marine Drive, Boardman, Oregon 97818.

The purpose of the meeting is to consider an ordinance or resolution authorizing the proposed plan of financing whereby Threemile Farms, LLC, an Oregon limited liability company (the "Company") has requested the issuance by the Port of up to \$20,000,000 industrial development revenue bonds (the "Bonds"), in one or more series, for the purpose of acquiring, construction and installing certain solid waste disposal facilities which are an integral part of the Company's three proposed dairies and to pay costs of issuance of the Bonds.
