INTENT TO VACATE A PORTION OF COUNTY ROAD NUMBER 971, know as COLUMBIA LANE
In accordance with ORS 368.346, The Morrow County Court will hold a public hearing to determine if the proposed vacation, Resolution #4-2010, is in the best interest of the public. The hearing will be held at the Irrigon Annex, 205 NE Third St., Irrigon at 11:00 a.m. on July 14th. As stated in Resolution #4-2010, adopted on May 12, 2010, Morrow County intends to vacate a portion

of County Road 971, known as Columbia Lane, the location of said vacation more particularly described as follows:
TRACT I

Also a strip of land 50 feet in width, being the northerly 50 feet of the existing right of way herein described, situated in the SW1/4 of SW1/4, the SE1/4 of SW1/4 and the SW1/4 of SE1/4 of Section 24, in T.5N., R.26E., W.M., lying between the Centerline of the abandoned Oregon-Washington Railroad and Navigation Company and a line parallel to and 50 feet southerly of said centerline, measured at right angle to said centerline, being that part of said strip lying easterly of the west line of the SW1/4 SW1/4 of said Section 24 and southerly
