Comprehensive Plan Amendment AC-026-10, AC(M)-027-10, and AZ-028-10: Willow Farms, LLC applicant and owner. The property is zoned EFU described as Tax Lot 1401 of Assessor's Map 2N 23, and located approximately 3 miles north of Cecil on Ewing Road.

Request is to amend the Comprehensive Plan to include a Goal 5 significant aggregate site to Morrow County's list of significant aggregate sites and approve mining, also to amend the Comprehensive Plan and Zoning Ordinance Maps to include the site within the Significant Resource Overlay Zone.
