Open Class fruits, vegetables and flowers will also be accepted on Monday from 4-8 p.m. and Tuesday morning from 8 a.m. until

10 a.m.

This year all Open Class exhibits will be released on Sunday morning from 9 a.m. until 11 a.m. at the same time 4-H exhibits are released.

If for some reason exhibitors can't make it on Sunday morning, the Fair Office will be open Monday

through Friday the week following fair from 8 a.m. -12 p.m. and from 1-5 p.m. for pick-up of items.

After 30 days those exhibits that are left will become the property of the Morrow County Fair and may be discarded, warns the fair secretary.
