

DA's Report

Morrow County District Attorney Justin Nelson has released the following report:

-Roberta Lynn Manning, 26, was convicted of one count of Criminal Trespass II, a Class C misdemeanor. Defendant was sentenced to 15 days jail time; however, execution of jail time was suspended and the defendant sentenced to 24 months bench probation, to include 20 hours of community service and no contact with the victim. Additionally, Manning was convicted of one count of Giving False Information to a Peace Officer for a Citation, a Class A misdemeanor. The defendant was sentenced to 180 days jail time; however, execution of jail time was suspended and the defendant sentenced to 24 months bench probation, to include 20 hours of community service. Additional counts were disposed without conviction. Fines, fees and assessments totaled \$893.

-In addition, Roberta Lynn Manning, 26, was convicted of one count of Failure to Appear II, a Class A misdemeanor. The defendant was sentenced to 180 days jail time; however, execution of jail time was suspended and the defendant sentenced to 24 months bench probation, to include 20 hours of community service. An additional charge of FTA II was disposed without conviction.

Fines, fees and assessments totaled \$350.

-Andrew Cody O'Neil, 31, was convicted of one count of Unauthorized Use of a Vehicle, a Class C felony, and sentenced to 18 months supervised probation, subject to 90 sanction units with 30 jail units. Conditions of probation include substance abuse evaluation, mental health evaluation, social re-education/life skills training program, five sanction units to be used for 80 hours of community service, and theft counseling. In addition, O'Neil was convicted of one count of Theft II and sentenced to 24 months bench probation, to include 40 hours of community service, theft counseling and letters of apology to the victims. Further counts were disposed without conviction. Fines, fees, assessments and restitution totaled \$1,362.

-In addition, Andrew Cody O'Neil, 31, was convicted of one count of Failure to Appear I, a Class C felony, and sentenced to two years supervised probation subject to 180 sanction units with 90 jail units. Conditions of probation include substance abuse evaluation, mental health evaluation, social re-education/life skills training program, completion of community service, and a written apology to the victim. Fines, fees and assessments totaled \$200.
