Northeast Oregon private pesticide applicator CORE Training is set for Tuesday, Dec. 16, from 9:45 a.m. - 3 p.m. The Morrow County Extension Service will be a participating site for this free training session that will be delivered via video-conference.

The course is divided into two two-hour sessions, which allows participation in either morning or afternoon session (two credits each) or both sessions (four credits total). Oregon pesticide applicator re-certification credits earned during this training will count either as CORE or general

credits.

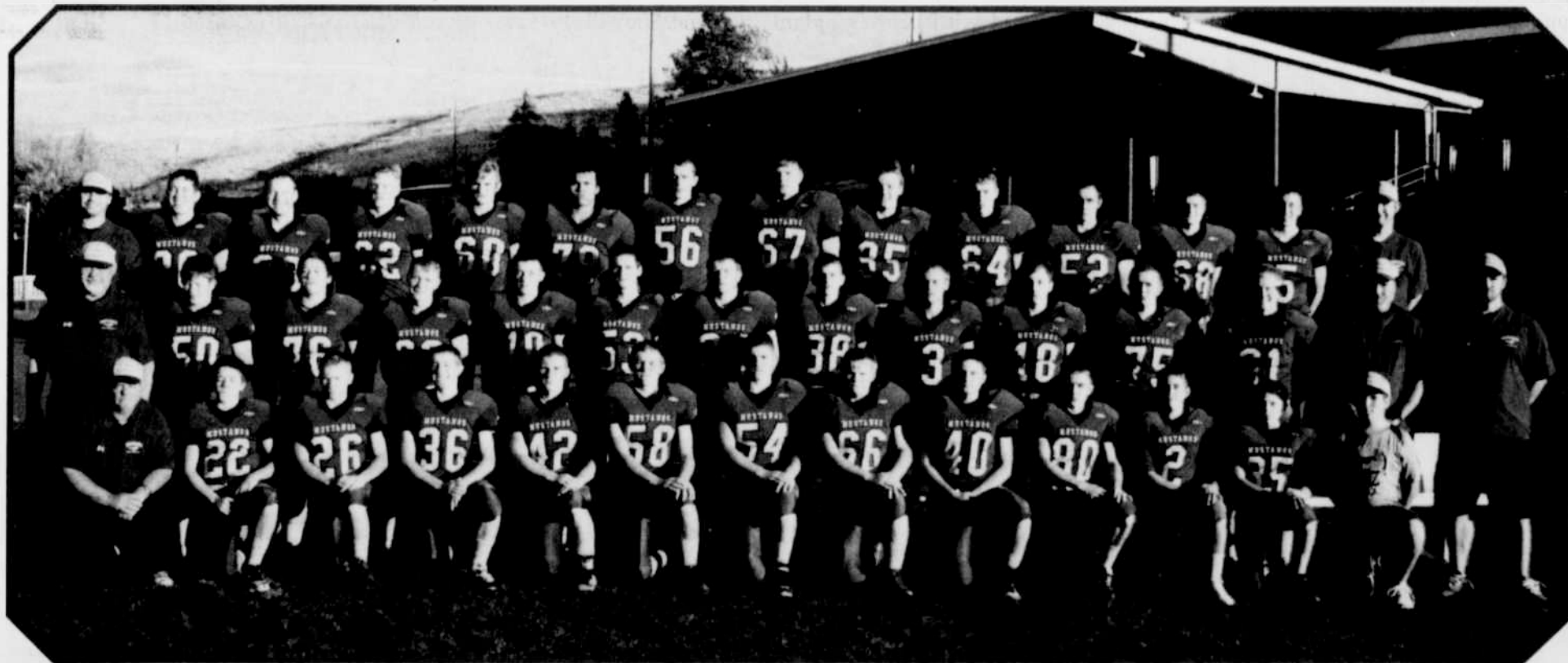
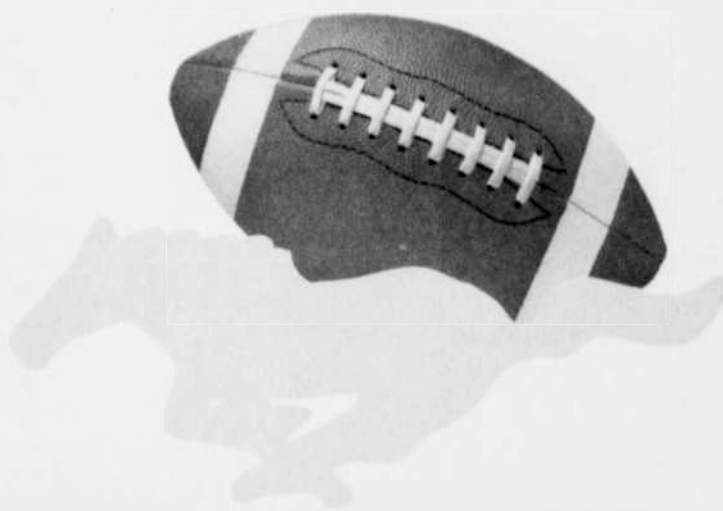
## Community lunch menu
