New Infant Day Care Center opens in Heppner

A new Heppner Day Care Infant Center has opened in Heppner. The center will take infants from six weeks to three years old. The center is open from 7:30 a.m. to 5 p.m. Monday through Friday and will have a staff of three. As of last week the center had already proven popular, with seven of its eight slots taken. People can stop and get an application and sign up on the waiting list, however. It is located at 278 Main St. in Heppner.

To take care of the infants the center has a kitchen and will serve breakfast, lunch and a snack. Food is provided except for formula. The three-person staff is trained in CPR and first aid.


WCVEDG announces second-round grant recipients
