The general obligation bonds were sold on and September 15, 2015 Boardman Park & Recreation District received a net \$12,700,455.60 from the proceeds of the sale. Boardman Park has engaged an architect and general contractor. Construction of a 40,000+ square foot recreation center has begun. The construction is planned to be completed approximately May, 2017.
