-MCSO received a report at Marquardt Rd/Pettys Canyon Ln, Lexington that there is a black calf in the road.

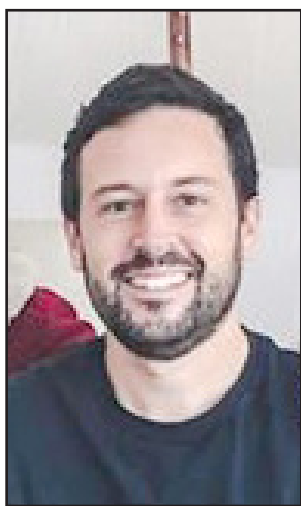
-MCSO received a report on Washington Ln, Irrigon that a male pulled a gun on him and ran up the road to the east.
