

Sheriff's Report

The Morrow County Sheriff's Office has released the following information:

May 11: Morrow County Sheriff's Office received a report at Green Acres on Paterson Ferry Rd, Irrigon that there is a man and woman fighting, verbal and maybe physical.

-MCSO received a report on Hwy 207 Echo, Echo that a white Nissan Frontier is broken down on the side of the road.

-MCSO received a report on SW Wyoming Ave, Irrigon of the theft of two pistols. They were last seen summer of 2018.

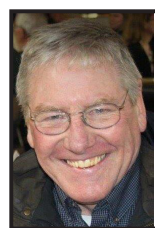
-MCSO received a report on SE Utah Ave, Irrigon that a gray Kia sedan ran the stop sign and is double parked. Unfounded.
