But now, their family needs help. Kelly and John's five-year-old grandson, Evan, the son of Jon and Brooke (Boyer) Kates, Boise, ID, was born with AVM, a rare congenital abnormality of the brain.

AVM, a brain arteriovenous malformation, is a tangle of abnormal blood vessels connecting arteries and veins in the brain, which disrupt normal blood flow and oxygen circulation. The affected arteries and veins can weaken and rupture, causing bleeding in the brain, stroke or brain damage. Some people can have this abnormality their entire lives with no problems, but Evan developed

Kelly and John Boyer an aneurism that ruptured and bled in his brain. His mother, Brooke, a former nurse, knew something was terribly wrong with Evan and took him to the hospital on March 3.

> Evan then suffered respiratory distress from mucous that had accumulated and required an emergency bronchoscopy to save his life. He suffered five strokes and developed severe vessel constriction in his brain, which caused additional strokes. Because the pressure in his brain was so high, he was put into a deep coma for three weeks and then was finally awakened on March 28.
