Making a decision about COVID-19 vaccination

possible development of auto-reactive antibodies; and toxic effects of any non-native nucleotides and delivery components" (Op. Cit. Jerusalem Post). The general public will be the guinea pigs for this mass experiment with no known assurance of immunity, but significant unknown and potentially life changing auto immune problems.
