Replat R-S-063-21: G Hughes Property, LLC and John & Diane Kilkenny, Applicants and Owners. The property is described as tax lots 800 and 1300 of Assessor's Map 2S 28E. The property is zoned Exclusive Farm Use (EFU) and located 11 miles east of Heppner on Highway 74. Request is to adjust a shared property line which would reconfigure a portion of Partition Plat 2000-01. Criteria for approval includes the MCZO Section 3.010 Exclusive Farm Use (EFU) and Morrow County Subdivision Ordinance Article 5 Land Partitioning.

Project No. 3-41-0034-009-2020 will be received by Matt Scrivner, Morrow County Public Works Director, at the Public Works Office, 365 West Highway 74/PO Box 428, Lexington, Oregon 97839, until the bid closing time of 11:00AM, on the 25th day of March 2021, at which time the bids will be publicly opened and read. Bidders shall submit the required first-tier subcontractor disclosure form within two working hours of the bid closing time. Bidders whose bids and/or disclosure statements are received after the stated times will be considered non-responsive and their bids will not be considered.

The scope of work being considered is:

1. Minor crack repair of Runway 8-26, Taxiway A, Taxiway B, Taxiway C, Parallel Taxiway, and Apron;
2. Seal coat of approximately 65,000 SY of Runway 8-26, Taxiway A, Taxiway B, Taxiway C, Parallel Taxiway, and Apron;
3. Non-precision instru-

ment runway pavement markings;

4. Relocation or disengagement of lighted holding position guidance signs (3 total);
5. Installation of Runway 8 REILs;
6. Installation of Runway 26 REILs;
7. Replace radio control equipment; and
8. Electrical room modifications as required to complete the work.

Contractors must be qualified in accordance with the applicable parts of ORS 279C in order to enter into a contract with Morrow County Public Works. Morrow County Public Works will only consider contractors who are able to demonstrate prior experience with similar work. Morrow County Public Works may investigate to determine the qualifications of the bidders as part of the evaluation of the bids. Bidders must submit qualification statements in accordance with the terms of Subsection 20-02 of the specifications with their Proposal. Proposals submitted without qualification statements will not be accepted.

Bidders must submit qualification statements in accordance with the terms of subsection 20-02 of the General Provisions (FAA) with their Proposal. Proposals submitted without qualification statements will not be accepted.

Contractor licensing under ORS 468A.720 for asbestos abatement is not a requirement of this project. No bid shall be considered unless the bidder is registered with the Oregon Construction Contractors Board or licensed by the State Landscape Contractors Board as required by ORS 671.530. The County will not receive or consider a bid unless the bid contains a statement by the bidder that the bidder will comply with ORS 279C.838 or 279C.840.

This contract will be funded, in part, by a grant from the Federal Aviation Administration. As such it will be subject to federal requirements. These include, but are not limited to:

 - Foreign Trade Restrictions;
 - Prevailing Wage Rates. All labor shall be paid no less than the minimum wage rates established by the US Secretary of Labor (Davis Bacon) or the State of Oregon (BOLI) whichever is greater.

 - Government wide Debarment and Suspension Provisions; and
 - Government wide Requirements for Drug-free workplace.
- All applicable federal provisions are given in the specifications under FAA Required Provisions.

In accordance with federal requirements, Morrow County Public Works has determined that this contract has subcontracting possibilities and encourages the participation of Disadvantaged Business Enterprises as prime contractors and subcontractors. A non-mandatory DBE goal of 2.1% has been established for the project.

Based on the 9th Circuit Court Decision in Western States Paving Company v. Washington State Department of Transportation, Morrow County Public Works has determined that it is appropriate to use a race/gender neutral goal. Morrow County Public Works encourages all bidders to take active race/gender neutral steps to include DBE's in this contract. Race/gender neutral steps include: unbundling large contracts, subcontracting work the prime contractor may self-perform, providing bonding or financing assistance, providing technical assistance, etc. This contract can be awarded without the lowest responsive bidder meeting the goal or demonstrating good faith effort to meet the goal.

Each prospective bidder is requested to attend a non-mandatory pre-bid meeting to be held at 11:00AM, local time on the 11th day of March 2021, at

the Airport Office. At this meeting, questions concerning the Contract Documents and the proposed work will be discussed. Answers and clarifications will be in the form of written addenda to the contract and will be uploaded to QuestCDN.

Proposals must be submitted on the prescribed forms and must be accompanied by certified check, cashier's check, or bid bond executed in favor of Morrow County Public Works in an amount equal to ten percent (10%) of the amount bid. Each Bidder must supply all information required by the bid documents and specifications. The successful bidder will be required to furnish a performance bond and payment bond, each in the full amount of the contract price.
