

**Sheriff's Report**

The Morrow County Sheriff's Office has released the following information:

-MCSO received a report at St Patrick's Senior Center on N Main St. in Heppner that the caller advised that he had lost the keys to his apartment.

**December 27:** Morrow County Sheriff's Office received a report on S.E. Park Place in Irrigon of a loud noise like someone revving a motorcycle or a loud chainsaw. MCSO responded and advised the owner to use chainsaw another day.

-MCSO received a report at Bella Vista Estates on Paul Smith Rd. in Boardman that the caller heard someone trying to get into her residence and/or possibly shots. BPD checked the area, but was unable to locate anything or anyone suspicious in the area.
