Morrow County Subdivision Ordinance and Zoning Ordinance Amendment AS-138-22 and AZ-139-22 This action is to update the Morrow County Subdivision Ordinance and relevant sections of MCZO Articles 9 and 1. Applicable criteria include MCZO Section 8.040 Amendments.
