Recalls launched against Commissioners **Lindsay and Doherty**

Will need 564 signatures for a recall election

A meeting called to discuss the recent firing of county administrator Darrell Green, and at the same time launch a recall effort against Commissioners Melissa Lindsay and Jim Doherty, was held in Heppner Monday night.

The 30 people attending heard from recall petitioners Corol Mitchell and Annetta Spicer, both of Heppner, on reasons for initiating the recall effort. The crowd later also heard from Boardman Rural Fire Chief Michael Hughes, whose organization is not sponsoring either recall petition, but for different reasons is joining

in on the effort. Reading from her petition, filed with the county clerk last Friday, Mitchell said Lindsay has violated the public trust of the people who elected her. "Commissioner Lindsay has violated that trust in many ways, one being by intimidating county employees, resulting in either their firing or leaving their jobs under duress. Commissioner Lindsay has repeatedly exhibited unprofessional behavior in her role as a public official. Commissioner Lindsay's actions have created county wide disapproval with other government and charitable organizations refusing to listen to them," Mitchell said. "The action of the firing of the Morrow County Administrator, with of county taxpayers no transparency, refusing to let the public speak, or answer the administrators' questions about why he was sitting there, made it clear that in the remaining time of her tenure, this behavior would continue and could cause added financial burdens to our county. To prevent irreversible damage, an immediate recall is the only answer," Mitchell's statement concluded. Although not in attendance Lindsay was contacted by the Gazette-Times for a statement which is printed in its entirety below.

read her statement on the recall petition she had filed against Commissioner Jim Doherty Monday. "Commissioner Doherty's decisions are not in the best interest of the Morrow County citizens. He is not open and transparent in his actions as commissioner, making decisions in secret and outside of public purview and without the inclusion of the third county commissioner," Spicer told the crowd. are not held in accordance with public open meeting law requirements. Doherty does not cooperate with agencies to the detriment

Morrow County employees have demoralized county employees and has been detrimental to a functional county government. Decisions are not made in the best interest resulting in fiscal

detriment to the county, Spicer concluded. Contacted by the Gazette-Times Doherty said he had no comment.

Members of the public, recall on the ballot. including Lindsay supporters, were allowed to speak and at times the discussion got heated, with Spicer repeatedly asking participants to be brief, allow others to speak and not interrupt. Also, some people from Boardman and Irrigon attended the meeting. At one point a member of the crowd did call for a sheriff deputy to come to the meeting, however he did not arrive until the meeting was almost over and there were no physical confrontations at the gathering which was held at the local pizza shop across the street from the courthouse in Heppner.

Also speaking at the gathering was Boardman Rural Fire District Chief Michael Hughes, whose organization has a separate complaint against the two commissioners. Hughes' organization is in a dispute with both the county commission and the Morrow County Medical District about ambulance service in the Boardman area.

Hughes says he wants his organization to be able to provide ambulance service in north Morrow County, however the county has so far not granted him that license. The issue has become involved over discussions of authority and state regulations with both

the fire and health districts hiring lawyers over the dispute. Hughes has been to several county comother public and private mission meetings asking for the license, with both of Morrow County citizens. Doherty and Lindsay so His decisions regarding far not granting it. Some

According to County Clerk Bobbi Childers, the petitioners will have 90 days in which to gather 564 valid signatures of registered county voters and return them to her office. The clerk then has 30 days to validate the signatures and make sure they are legitimate. The clerk will then inform the recalled commissioner of the validated petition and the commissioner then has five days in which they can resign, or a county-wide recall election must be held within 35 days. Petition gatherers have indicated they are shooting to gather 700 signatures to ensure they meet the validation threshold.

According to records not only has a county commissioner never been recalled in the 137-year-old history of Morrow County, but a recall effort has also not even been successfully initiated against a commissioner. Morrow County was created in 1885 from the western portion of Umatilla County and a small portion of eastern Wasco County. It was named after Jackson Lee Morrow, an early settler in the area and member of the Legislative Assembly when the county was created.

If the recall election is

successful against Lindsay she would be removed from office and the remaining two board members would choose a successor to fill out the remainder of her term, which expires in January 2023. Heppner resident David Sykes was recently elected in the primary to position number three, Lindsay's current spot. Lindsay had not run for election in position three but chose instead to run in the recent election for position number two. She lost by 27 votes to Irrigon resialthough their reasons dent Jeff Wenholz. Current position two commissioner Don Russell chose not to seek re-election.




