Blends were a 50/50 (%) mix of both varieties. Grain protein data not yet available. Stripe rust pressure was low-to-moderate at this location. **Fungicide** was **not applied**. Plant height of LCS Shine is less than that of other varieties grown in eastern Oregon.*
