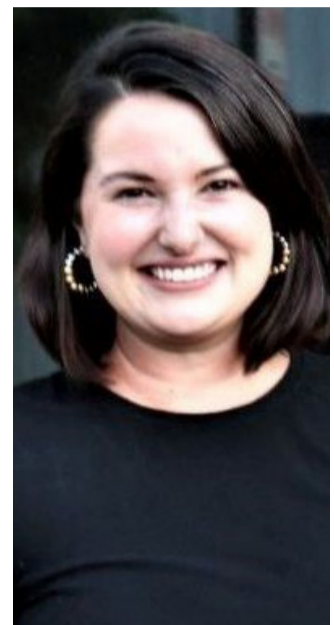

The Heppner Chamber of Commerce has introduced its new management team.

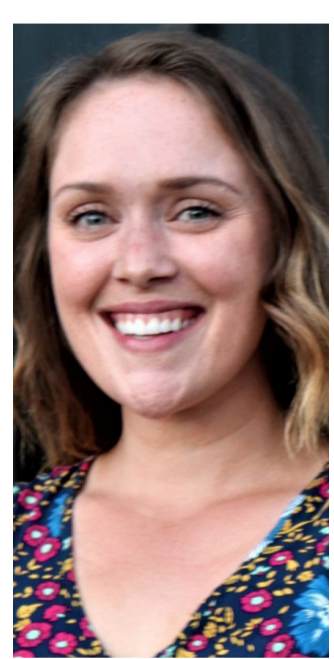
