MCSO March 19th

Criminal Mischief Complaint

Occurred at Bombing Range Rd/Strawberry Ln, in Lexington, OR. RP needs to report a windshield that was busted out of a track hoe. RP is available by phone for contact. Disposition: COMPLETED.

Noise Complaint

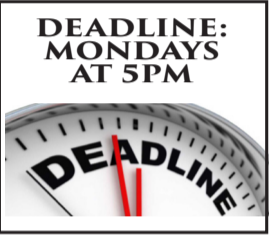
