The meeting is open to the public in person and online. The meeting agenda with Zoom link can be found online at https://www.co.morrow.or.us/meetings. The committee is accepting applications from livestock producers to assist with expenses they incurred due to wolf activity. The Committee determines the distribution of funds from the Oregon Department of Agriculture's Wolf Depredation Compensation & Financial Assistance Grant Program. Funds are available for Category 1 (direct loss claims), Category 2 (missing claims, and Category 3 (non-lethal preventative techniques), however Missing Claims are paid

in the next grant cycle, if awarded by ODA. The applications can be found on the County website: https://www.co.morrow.or.us/bc-wdac.
