privilege of doing business on the fair grounds. No argument is necessary to show that we want the people to come in droves to see our fair. How to get them is no problem if sane methods are adopted in advertising and prices of admission. Simply let it be known that 25 cents with pass checks out and in will be the charge for a whole day and the problem is solved. The announcement would do all the advertising necessary and bring the people here by the thousands. Less season tickets would be sold, probably, but more money would come in and the concessionaires would be able to meet their expenses and make something besides. Scarcely a concession on our grounds but what lost money this year; the same thing happened at Vancouver and even at Salem with the attendant result that it is going to be hard for the fairs to do business with them next year unless there is some change in the policy to be pursued in these directions.

As to season tickets, there would be many more sold if each buyer could be allowed an entry of one article or a thousand with the purchase of each ticket. The result would be an overflowing of the pavilion and stock sheds, as practically everybody would come and bring something along for exhibition.

Commercial clubs and Civic associations should be encouraged and placed on an equality with the granges, but all of them should be required to confine their exhibits to products of the soil. Fancy work, domestic science and art should have no place in such displays. Such articles should go to their various departments. They are out of place along with potatoes and turnips and would make the textile, art and cooking departments much more attractive if displayed there, as they should be.

There are other ideas as to the running of a fair that could be thought of by almost anyone, but reforms are hard to bring about. An unflinching interest should be uppermost in the minds of all for without enthusiasm there can be no success. So let us all get together for a bigger and better fair next year. And let us be independent of all other fairs in fixing our dates. It makes no difference if we do conflict with any of them except the State Fair. The country is getting more densely populated all the time and we of Multnomah are capable of pulling off our own stunts independent of all the others if we so choose.
