HONORED MOTHER GOES TO REWARD

The last ceremonial of the living for the dead was performed over the mortal remains of Mrs. Elizabeth Gullikson on Saturday, when she was laid to rest in the Gresham cemetery. Following is a brief review of her life:

Elizabeth Gullikson, whose name was Hansen, was born in 1830 in Norway. She came to America when a young woman. After marriage to Ole Gullikson, she lived in Iowa county, Wisconsin for sixteen or eighteen years, and then moved to Grant county, Wisconsin, on a farm near Anaton, where she lived for 19 years. Her husband died in 1881. She moved later to a place near Montfort, Wisconsin. She came to Oregon about six years ago and continued to reside here till the time of her death. Most of the time in Gresham. A year ago she went to Portland to stay with her youngest daughter and was taken ill. She was continuously indisposed till the time of her death which occurred at 5:45 a. m. the 15th of January. She died of old age and passed away unconscious. She was a member of the Norwegian Lutheran church.

Mrs. Gullikson leaves ten children, nine of which are living. The deceased one being the late Henry Gullikson. They are as follows: G. W. Gullikson, of Wagner, S. D.; Andrew Gullikson, of Plattville, Wisconsin; Mrs. Julia Williams, Fenimore, Wisconsin; Mrs. Mary Brown, Seattle, Washington; Mrs. J. W. Robinson, Lester Prairie, Minn.; Mrs. B. Hayes, Albany, Oregon; A. Gullikson, Gresham, Oregon; Mrs. Lena Needham, Seattle, Washington; Mrs. Christina Humason, Portland, Oregon.

Through a long and varied life Mrs. Gullikson served well her day and generation, rearing a large family and sacrificing much on their behalf. Always kind, gentle, true and unselfish, putting her faith and trust in a higher power.

DR. J. P. POWELL HOMESTEAD, SITE OF AUTO FACTORY

The statement that work had actually begun on the first unit of the factory was literally true, but operations were confined that day to staking off the grounds.

Last Friday's Outlook, in a lengthy article authorized by Frank McCullis, confirmed every detail heretofore published concerning the plans and movements of the Beaver State State Motor Company.

The contract for the first building was signed on Saturday evening last, about 5:30. The contractor is James P. Taylor, of Portland, who spent yesterday in assembling tools and materials for the work, and from now on the busy hum of the builders will give to the hitherto quiet old Powell farm an awakening that it will probably never experience again, for its days of quietness are of the past and it will take its place as a part of a lively community, where the hum of industry will transform it into a living world of commercial importance.

The plans of the company are fast shaping themselves toward the early manufacture of a first-class automobile and a type of motor truck that

is sure to become one of the successful needs of the public. Orders for both are already in the hands of the company to cover a great number of the machines it will be possible to make this year.

As stated before, the first building will be 60x200 feet, built of reinforced concrete. It will be one story high only, as there is no need for an upper floor in such a factory. It will be well lighted on both sides by many windows and be arranged inside for the special work to be done there. As other buildings are needed they will be built, and more of them will be an actual necessity before another year.

The above picture of the site is a familiar one to every resident of this section. It shows the old Powell home which will be left standing as it is, but it will be occupied by one of the officers of the company. It is not included in the five acres that will be covered by factory buildings, but the woodshed, the garage and potato cellar at the left will all have to give way to the march of progress. WILL EXHIBIT HOME PRODUCTS IN CARS

A state-wide campaign in the interest of Oregon manufactured products will be conducted soon from special cars which will visit almost all the cities in Oregon having a population of 400 or more. At a meeting held recently at the Commercial Club, a group of Oregon manufacturers endorsed a plan set forth by R. S. Hurd. One or two cars will be filled with exhibits of products made in Oregon. The exhibit will remain from a half day to two days in all the cities with a population of 400 or more on the lines of the Southern Pacific and O. W. R. & N. The territory to be covered will extend as far south as Ashland and eastward to Baker City.

Mr. Hurd will make an advance trip to complete arrangements.

Addresses and an elaborate catalogue will be prepared, describing the exhibition and the need of patronizing home industries. The catalogue will contain prices of the products. A list of visitors to the exhibiting cars will be given to the exhibiting manufacturers.

TAXES PAYABLE ALL AT ONE TIME

Attorney General Crawford has given an opinion on how taxes shall be collected this year. He says that all taxes shall be due April 1. All unpaid taxes will bear interest or penalty of 1 per cent a month for five months or until September 1, at which time all unpaid taxes become delinquent. At that time there will be accumulated 5 per cent penalty and 10 per cent further penalty will be added to the total amount, making 15 per cent penalty due at that time. Then that full amount will draw 12 per cent interest until paid. Money for taxes must be paid all at one time hereafter as the two payment plan has been discontinued by the new law.
