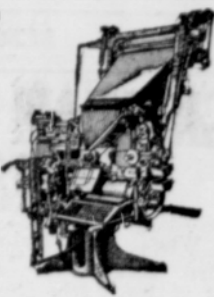

MISSIONARIES VISIT COAST

PORTLAND, Jan. 14—(Special)—

A team of eight prominent Chinese Presbyterian missionaries, who are making a tour of the Pacific coast, speaking in the interest of foreign missions under the auspices of the Presbyterian board of Foreign Missions, will be in Portland from February 1 to 6.

The team is composed of Rev. A. J. Furth, D. D., Canton; Rev. J. C. Garrett, D. D., Nanking; Rev. C. A. Killig, D. D., Paotingfu; H. W. Ling, D. D., Hunan; Rev. W. T. Locke, D. D., Huna; Rev. H. W. Lusce, D. D., of the Christian University of Shantung, Wie Hsiu; Rev. C. C. Patton, D. D., Ko. China.

Rev. Ernest F. Hall, of San Francisco, district superintendent of Foreign Missions on the Pacific Coast, is with the missionary team. At present these missionaries are speaking at Spokane, Seattle and other points on the coast.

Committee arranging for their appointments in Portland are Rev. Robert McLean, of the Anabel Presbyterian church, chairman; Rev. H. N. Mount, of the Vernon church; Rev. W. C. Moore, of the Mount Tabor church; Fletcher Linn and J. E. McGaw.

The missionaries are expected to arrive the day before Sunday, February 1. On Sunday, February 1, the eight missionaries will speak morning and evening in the Presbyterian and United Presbyterian pulpits of Portland, Monday, February 2, Rev. C. A. Killig, will deliver an illustrated lecture in the First Presbyterian church.

This will be a union meeting, Tuesday night, February 3, a reception and banquet will be served in the community house of the First Presbyterian church. Plates will be placed for between 400 and 500 guests.

Wednesday night it is expected that a Christian Endeavor rally will be held in the First church under the auspices of the Christian Endeavor Union of Portland.

These are the church appointments. February 4 the missionaries will speak at 9 a. m., to the students of the Washington and Jefferson high schools. Also addresses will be made at the Portland Academy, the Lincoln high school and the Reed college.

W. C. T. U. COLUMN

The Gresham saloons have appealed their case to the supreme court. They would save money and friends by gracefully accepting their defeat.

The local option elections of November 4 have received the sanction of several of the courts, and the disapproval of one, viz: Judge Galloway of Salem.

Judge Campbell upheld the legality of the local option vote on November 4 in the case of Oregon City and Hillsboro. Judge Kavanaugh did so in the case of Gresham. Judge Harris did so in the case of Springfield. Judge Hamilton mandamus the county court and compelled the holding of an election at that time in the case of Sutherlin, and the circuit court of Jackson county similarly mandamus the county commissioners of that county and compelled the holding of a local option election in Eagle Point.

Judge Galloway takes the opposite view, and holds that a city may not vote upon a local option question in the alternate year between the general election unless its city election happens to fall upon that day. Reductio ad absurdum.

Admittedly county precincts may hold an election in the alternate year. It would seem ridiculous to say that county precincts may hold an election every year, but that incorporations may only vote every other year unless, in the rare case that a regular city election is set for the first Tuesday after the first Monday in November and falls on the alternate year.

Ohio Bull Moosers Declare for National Prohibition.

We suggest for the consideration of the convention which will be held

for the adoption of the platform the following propositions:

1. The Progressive party is in favor of real, not sham, home rule. We are opposed to any interference by the state executive authority, through commissions or other agencies, with the principle of local self-government.

2. An honest and impartial enforcement of law is essential to good government. The public official who refuses to enforce the law is as great a menace to the public welfare as the law violator. No backward step should be taken on local option laws and other legislation which protects and promotes the moral welfare of the state.

Columbus, Ohio, January 3.—Yesterday, was held here a conference of the Progressive party of the state—the Bull Moose folks.

And the liquor problem was the thing that attracted the greatest amount of discussion and interest. After discussing the matter informally last evening and formally today, it was decided to declare for the submission by congress of an amendment to the states of a prohibitory amendment to the federal constitution. The text of the deliverance is given above.

Surprising to the party leaders was the temperance sentiment which swept them off their diffident feet, as they found the new party had reached the stage of all other big parties, that of having to deal with the wet and dry question. Many delegates demanded a declaration for state prohibition. Solution of the problem was a declaration for the submission to the American people for adoption of a constitutional amendment, giving congress the power to deal with the liquor question.

Prohibition Amendment Day.

The W. C. T. U. of Gresham in accordance with the proclamation issued by the national president that January 15 be observed as a day of fasting and prayer, met at the Baptist church where the national program was carried out as nearly as possible. The meeting was called to order by the president, Mrs. Shoemaker. After prayer and a short business session, the meeting was turned over to the leader, Mrs. Wostell, who very ably conducted the program, beginning by reading the Crusade psalm, and singing the Crusade hymn. Special thoughts on Exodus 14: 15, were given by Mrs. Shoemaker. Mrs. Exley read the proclamation for National Constitution Prohibition issued September 11, 1912, by Mrs. Lillian M. N. Stevens, president of the National W. C. T. U. Special prayer was offered for all national leaders throughout the United States. Special thoughts on John 14: 14, were given by Mrs. Oilphant and greatly appreciated by all.

The joint resolution introduced into congress by Hon. Richmond Pearson Hobson was read. Prayer was offered for the president of the United States, governors, senators, and congressmen, members of legislative committees in Senate and House of Representatives and for congressman Hobson.

Special thoughts on Isaiah 65: 24, were ably given by Mrs. Davidson. Plans for the National Constitutional Prohibition amendment campaign was discussed by all present.

According to the annual report of the Portland Union Stockyards company, Oregon, marketed more livestock during the past twelve months than during any other similar period in the state's history. Not only was 1913 a record-breaking year in the production and marketing of livestock, but Oregon farmers, received the best prices ever paid in the test for all classes of meat animals, the prices for hogs, especially, being higher than in any other market in the United States. From shipments originating wholly in Oregon, the company received 40,329 cattle, 3,069 calves, 217,634 sheep and 94,319 hogs, the latter of an average weight of 218 pounds. The present year is also starting out with a most encouraging movement of stock, the local yards having received in one day, January 12, a total of ninety-nine carloads of meat animals of all kinds, of which 53 carloads originated in this state. With Oregon farmers increasing their holdings of stock while paying careful attention to the production of animals of better quality, there is every reason to believe that 1914 will equal, or surpass, the record of last year.
