PRO-LIQUOR ADVERTISEMENTS.

It is evident a big slush fund is being poured into Oregon newspapers by the liquor interests for pro-liquor ads.

It is to be observed that the saloon men are paying the cash for advertising. They have a paying business which they are spending lots of money to defend.

For the average newspaper to take the stand on the side of decency, morality and temperance means immediate loss of subscribers and advertising.

As an instance of this we reprint the following editorial from the Evening Telegram:

TRAT BOOZE CARTOON.

Some anonymous person, manifestly a man engaged in the liquor traffic, takes the trouble to send us a recent Telegram cartoon in which death was represented as riding in an automobile laden with booze.

Our friend should not forget that these things work both ways. We have seldom heard more favorable comment upon a cartoon than those which poured into us from people who approved of it.

KEEP THE STANDARD UP.

The measure known as the Dentistry Bill should be defeated, because the laws regulating the practice of dentistry, as they now stand upon the statute books, are framed for the protection of the public and not for the special privilege of dentists.

We are asked to do away with this protection by lowering the qualification of persons seeking to practice dentistry in Oregon.

The efforts of 25 years to bring the dentistry laws of Oregon to their present standard will be destroyed. The "joker" in the Dentistry Bill is this:

Section 1. "The following persons shall be entitled to practice dentistry in the State of Oregon."

"First: A graduate of any reputable dental college in good standing which requires a course of study of at least two school years, having a yearly course of study of not less than six months."

There is no longer a reputable dental college in the United States with a course of only two years of six six months each. All standard dental colleges now require at least three years of eight months each.

The standard should be kept high, not lowered to accommodate a few quacks.

DOCTORS ARE FEWER.

Since the number of medical colleges in the United States has decreased about one-third during the past ten years and the number of medical students today number only 16,000 against 29,000 ten years ago, it is an interesting question to ponder over—what has been the cause of the slump?

The cause is not difficult to determine since it is embraced in the single phrase, "not enough in the job to live on." So many young doctors have barely eked out an existence that the returns have not justified the expense of securing the necessary education.

Then, too, the standards set by the medical colleges have discouraged many from entering who were perhaps too dilatory in their preparatory work. The world will be better off with fewer and better doctors.

Enterprise is a prime factor in any business and works well on the farm. An example in the latter field is found on the Allhouse place on the Section Line road near Rockwood. While Mr. Allhouse has charge of a garage in Portland Mrs. Allhouse directs the work on the farm. Their specialty is potatoes and hogs.

A movement has been started by the Oregon Jersey Cattle club to induce the government, through the Bureau of Animal Industry, to send three or four experts into this state to assist in the work of inspecting the herds as a safeguard against tuberculosis.

L. M. Lepper reported that figures on the cost of illuminating Grand avenue for electric and gas lighting, were being obtained and would be ready to submit to the club and property owners on the street within the next ten days.

The city primary election in Milwaukee has been fixed for November 2, the day before the general election. Mayor E. T. Elmer and none of the councilmen are candidates for re-election, except Charles Counsel who may run for councilman-at-large.

It is announced that the terms Portland requires from Milwaukee for supplying Bull Run water are prohibitive and eliminates Bull Run water from consideration. Full report of these terms will be submitted at the council meeting October 14.

While the delay in passing the Rivers and Harbors bill has, to some considerable extent, delayed work on the Cello canal, a small force of men has been kept at work through the summer and the engineer in charge estimates that if the necessary appropriation is made in the near future, which now seems probable, the canal can easily be completed within the next six months.

It is announced that a giant lumber corporation with a capital of several millions is planned by holders of large timber interest in Clatsop and Tillamook counties. It will build a fleet of steamers and maintain a string of eastern distributing yards.

The Pacific Power & Light company of Portland has been granted a franchise to furnish power and light to the city of Warrenton.

Plans are being prepared for a group of bridges to be built over the Cello canal.

Douglas W. Bailey, W. H. Furnett and Mrs. A. Deloch Rose of Pendleton have organized an industry to employ a dozen people in manufacture of women's toilet articles.

Dr. H. E. Morris, secretary of the McMinnville Commercial club, has assurance that a cannery will be built next year.
