NOT AIMED AT PARIS.

However desperate and bloody the German attacks upon the positions in the vicinity of Verdun may be, it is highly improbable that there is any purpose of breaking through to Paris at that point.

When there was no doubt about the intention of the Germans, the attempt to take Paris was not by way of Verdun. There are places where the German lines are not half so far from the French metropolis as they are in the neighborhood of the famous French fortress menaced by the latest important German offensive movement.

But if Verdun can be taken a heavy blow will be inflicted upon France and her allies. The prize is worth much in itself, not only because the fortress has a great reputation and stands at the angle of the trenches, but because it will be felt everywhere that if the Germans can take the greatest defensive works of the French and overcome their stubborn resistance, it is possible to do the same anywhere else.

It looks like a great effort to discourage the French people and make them willing to think of peace. The French army is the key to the cause of the allies on land. If it cannot hold its ground, at least, German prestige will mount higher than ever and French hopes and spirits will go down accordingly.

Some of these days somebody is going to come across with an effective substitute for gasoline as a motor fuel, and this talk about a possible gasoline famine is likely to speed things up. In the meantime, if enthusiasts can just restrain their feet from the accelerator, they will help to conserve the gasoline supply, and incidentally, the peace and dignity of those who are howling about the rise in gas.

PROMINENT ATTORNEY CANDIDATE FOR JUDGE



W. M. (PIKE) DAVIS.

W. M. Davis, better known throughout the county as "Pike" Davis, is a candidate for circuit judge in Department No. 3, the position now held by Henry E. McGinn who will not seek another nomination.

Mr. Davis has lived in Portland for 25 years, coming here from Pike county, Missouri. He was deputy city attorney there for six years. He was appointed in 1896 by W. M. Cake, then city attorney, and also served under City Attorney J. M. Long. He quit in 1902 to take up private practice.

Born in Illinois, but a resident of Pike county, Missouri, for 20 years prior to coming to Portland, Mr. Davis is 49 years old. He was admitted to the bar in Missouri when he was 22. The day after being admitted he was elected city attorney of Louisiana, county seat of Pike county.

Up to this year Mr. Davis had been for several years a member of the executive board of the State Bar association. He organized the Multnomah Bar association.

He was one of the initiators two years ago of a measure for a non-partisan judiciary. In the last campaign he was head of the Men's Equal Suffrage League of Oregon and devoted three months of his time to its work. He has a host of friends in the ranks of organized labor who will actively support him.

AGAINST LARGE STANDING ARMY

A. W. Lafferty Urges Enforcement of Land Grant to the Letter.

Republican ex-Congressman Expects to Win May 19.

"Against a Large Standing Army." The foregoing is the first plank of A. W. Lafferty's platform for renomination to congress at the primaries to be held on May 19.

Mr. Lafferty has twice been elected to congress from Portland as a Republican. He has always been affiliated with that party and has never at any time registered otherwise.

Would Open Lands.

The second plank in Mr. Lafferty's platform reads: "For enforcement of Oregon's great railroad land grant by the sale of every acre, timber and all, to actual settlers at \$2.50 per acre, under a drawing system to be conducted by the federal court at Portland, thereby giving to every one an absolutely equal opportunity."

The unsold railroad lands aggregate 2,300,000 acres. Cummins May Help. Mr. Lafferty will send to each voter, under the frank of Senator Albert B. Cummins or other national leader who is friendly to Mr. Lafferty's campaign, the speeches which Mr. Lafferty delivered in congress in 1915, just before his term expired.

These speeches deal with preparedness, the present status of the land grant case and other live issues. The thorough distribution of literature will be supplemented by a personal canvass. Mr. Lafferty is confident of victory.
