HIGH SPEED AND PARKING LAW PASSED

Gresham now has an operative automobile ordinance which was passed unanimously at the regular meeting of the common council on Tuesday evening last. The penalties for its infringement are a fine of from two to fifty dollars or imprisonment from one to twenty-five days, or both. Principal features of the ordinance are as follows:

It shall be unlawful for any person or persons to drive an automobile, motor vehicle, electric vehicle, or motorcycle within the corporate limits of the town of Gresham faster than a speed of twenty miles per hour.

That it shall be unlawful for the owner or driver of any automobile, motor vehicle, electric vehicle, motorcycle or horse-drawn vehicle to park or cause said vehicle to be parked for a greater period than thirty minutes on Powell street for a distance of fifty feet east of the intersection of Powell and Main streets or for a distance of fifty feet on Main street north from the north intersection of Main and Powell streets in the town of Gresham.

That it shall be unlawful for the owner or driver of any automobile, electric vehicle, motor vehicle, motorcycle or horse-drawn vehicle to park or cause said vehicle to be parked within less than twenty feet of any fire hydrant within the corporate limits of the town of Gresham.

A remonstrance against the proposed improvement of Roberts avenue from Second street to Division was presented. It contained fourteen signatures of property owners affected, which was enough to prevent the improvement. It was held over until a special meeting to be called by the mayor, but in the meantime a special committee consisting of Councilmen Miller, Burke and St. Clair will confer with the property owners in an attempt to come to some agreement upon the matter and endeavor to secure a petition favorable to the improvement.

Three new street lamps were ordered. A 400-watt lamp will be placed at the intersection of Powell street and South Roberts avenue; two 60-watt lamps on Powell street near the Gresham schoolhouse. The lamp near Schiller's station is to be moved south for better efficiency.

The city marshal was instructed to raise the sidewalk west of the schoolhouse on Powell street so as to conform to the street surface.

Engineer H. J. Stocker made report on survey of South Main street and suggested a new sidewalk of gravel from the foot of the incline to the O. W. P. property line. The matter was referred to the street committee with power to act.

The recorder was instructed to send a bill for \$8 to the city of Sandy for use of autos on the occasion of the recent fire.

Certain bondholders to whom money is due were notified that at the next interests date the rate would be reduced from 7 to 6 per cent.

Notice for publication was ordered, calling for the town caucus to nominate officers, same to be held in Metzger's hall on November 22, at 8 p. m.

CAMPAIGN NEXT WEEK TO RAISE \$35,000,000 FOR Y. M. C. A. ARMY WORK

Portland, Oregon, November 7, 1917.

Mr. H. L. St. Clair,

Dear Sir:—I have been requested to act as campaign manager for the Y. M. C. A. in its endeavor to raise \$1000 in Multnomah county, outside of the city of Portland, for the purposes set forth in the inclosed circulars.

I am requesting you to act as chairman of publicity, and to actively assist in conducting such campaign.

Will you kindly let me have your acceptance at the earliest moment so that I may call a meeting of such organization as I may be able to perfect at an early date?

We carefully considered the above request and have phoned to County Commissioner Holman our acceptance. We felt we would be a slacker if we did not accept this opportunity to help make a success of the effort to raise \$1000 from eastern Multnomah for the Y. M. C. A. War Fund.

The plan of campaign for this district has not yet been fully announced but will be worked out during the next day or two.

Next week is the week designated for the Y. M. C. A. National \$35,000,000 War Fund Campaign.

This campaign is undertaken under the direction of the National War Work Council of the Young Men's Christian Association of the United States. The headquarters of the Pacific Northwest is at the Y. M. C. A. building in Portland, with W. M. Ladd as chairman and H. W. Stone, campaign manager. The county has been districted and Mr. Holman is campaign manager for the district of Multnomah county outside of the city of Portland.

In brief this territory will be divided according to school districts, with a chairman for each school district. Speakers will be arranged for and meetings held to give information to the people. There will be a local committee in every school district. We are not able to publish these lists at this time but they will be announced probably in the daily papers and in full in Tuesday's Outlook. Also time and place of meetings.

There are three emblems that are coming to mean more and more to every American citizen, especially during this great World War for Freedom. They are first and foremost the beautiful Flag of Freedom—the Stars and Stripes—Old Glory; the second is the Red Cross, the emblem of medical and hospital ministrations on all battlefields; the third is the red triangle of the Y. M. C. A., emblem of the highest ideal of true manhood—physical and moral cleanness and efficiency.

The government equips, pays, sustains and directs the great fighting force, the army and navy, in its vast operations from first to last; the Red Cross cares for the sick and wounded and provides physical comforts in the way of extra clothing and comforts. The Y. M. C. A. is the only other organization officially recognized by the government and allowed to operate at army cantonments, at camps and on battlefields. Its work is to provide as far as possible home comforts and influences for the soldier boys in training and at the front. It looks after the moral and spiritual needs, provides a meeting place and wholesome games, music, and recreations. It seeks to throw around the boys a true brotherly, home influence making for decency and efficiency.

The present urgent call that comes to the Y. M. C. A. is to minister to the social, recreational, moral and spiritual needs of 6,000,000 men in prisons camps and 14,000,000 men under arms.

Millions of soldiers each month thank God for the friendly Y. M. C. A. centers as a relief from the hard, cold life of the camps and trenches. But it takes millions of dollars to continue and to extend this vital home touch—to keep these home ties from breaking.

At the meeting of the National War Work Council of the Young Men's Christian Association of the United States, held in New York City, September 21, 1917, and largely attended by members from every section of the country, the program for the War Work to July 1, 1918, was faced with solemn earnestness.

Reports based on accurate and painstaking investigations indicated that at least \$35,000,000 would be required to meet the needs with any adequateness. It was with a sense of deep conviction and obligation as well as of confidence that the National War Work Council voted unanimously to set aside the period November 11th to 19th inclusive to undertake the raising of this large sum of money—the largest ever called for at one time for any similar purpose.

The estimated cost of the other phases of the war to the United States government is over \$50,000,000 a day. Shall not the American people contribute at least \$35,000,000 for nine months of the constructive work of the Y. M. C. A. among American troops, among the 14,000,000 and more troops of our allies and for the 6,000,000 prisoners of war? Millions for defense through war; millions also for the defense of our warriors!

If our boys, tired, cold and mud-stained, could only knock at your door tonight, how wonderfully you would minister to them. With what eagerness you would comfort and feed them. You would do this in your homes. Help the Young Men's Christian Association to do this for you in the camps and at the front—where you cannot go. Help them by heroic giving. Some are giving thousands; others are giving tens of thousands, and large numbers are giving sums in proportion to their ability. All should have a share.

Our boys will give their lives to make America safe for you. They will make the supreme sacrifice to preserve democracy. What will you sacrifice to give them a touch of home love and cheer, to help keep the home fires burning in their hearts?

Whatever you can contribute should be given quickly. The severe bitter months are just ahead. The time is short in which to meet the urgent needs. Action must be immediate. For the sake of all that is best give—give until it costs sacrifice—give as you have never conceived possible heretofore—give for our boys in khaki!

Let's all do a super-bit—now!

SENDS TO CHICAGO FOR FARM WORKERS

A. J. Krueger, manager of the Wilson Stock farm, three miles west of Gresham, has nearly 150 acres of potatoes to be dug and has been unable to get adequate help to harvest them, along with his other farm work which is of immense proportions.

Last Monday he telegraphed to Chicago for five men, one of whom is an old acquaintance, to come here and go to work on the farm. They are on their way here and will be of great assistance in getting the potatoes in before the weather interferes with the work.

A great portion of Mr. Krueger's acreage is yielding an immense crop of potatoes, all of which were contracted for last spring, and it is imperative that they be saved. Help from Chicago is something extraordinary, but it is so scarce here that it was resorted to.

NINETY-SIX PER CENT SIGNED FOOD CARDS

Canvassers in School District No. 4, seeking signatures to the food pledge cards have finished their work. They found 324 families in the district and have the signatures of 310 of them. Nine families were away from home when the canvassers called, all of whom they feel sure will sign when they return. They will be called upon later. Five families refused to sign, but the reasons for their refusal are not given. The percentage of actual signers was ninety-six.

One peculiar thing was discovered by the solicitors—only one-half of the families in the district have children of school age. This would indicate conservation of another kind.

HOW TO BREW TEN GALLONS, OF HOME MADE

It had been hoped that with the advent of prohibition in Oregon the state had gone bone dry with the exception of the bootlegging activities in many places where whiskey is the principal contraband article. But little illicit distilling has been unearthed, and only two or three cases have been reported in which wine has been manufactured according to has been manufactured in opposition to the law.

But with all the precautions and the terrors of the law in front of the offenders there has been considerable done in the way of sending whiskey into Oregon on nearly every one of its borders, principally from California. It has been noticed and commented upon that there has been only a slight infringement of the law regarding beer being shipped into the state. It seems that beer shipments are unnecessary for the simple reason that it would be too risky with such facilities as are to be had for making and dispensing the beverage as is quite apparent to the intelligent observer.

On the lower floor of the auditorium, where the land show is being staged at this time, may be found a booth with a display of hops, caps and cappers, and other insignia of the beer business. Lying on the counter are stacks of little cards bearing the title "10-Gal.—Oregon Made" and people are urged to buy an outfit with "Directions Free."

It is not to be understood that the proprietor is advertising beer—far from it. His card of "directions" tell all about how to make "The Greatest Home-made Drink and Beverage in the Northwest." It is not necessary to repeat the formula here, as thousands already have it, but it is a good recipe for a soft drink. But here is the camouflage:

Requirements of the law: Such beverage for selling must not contain more than 1/2 of 1 per cent, which requires reducing 7 times and adding hops according to flavor desired.

Now, here is the evident assumption after reading the card: The above paragraph omits to say what the 1/2 of 1 per cent is. It may be alcohol or sugar or anything that a person pleases to imagine. And, following up the idea suggested, it is apparent that some people will omit or forget to reduce the concoction 7 times. In that event the original ten gallons is undoubtedly 4 per cent beer, and if a little more dope is added in the making it can be made stronger.

Then, again, who that makes ten gallons of the "greatest home-made drink and beverage" has facilities for saving 70 gallons for future use. A brewery might have, but hardly a single individual, and then it would probably be unsatisfactory to have to consume 70 gallons when the job can be accomplished by drinking ten gallons.

The proprietor had his exhibit at the state fair and was given the highest award. He will probably get another at the land show. He is not violating the law, but the fellow who makes ten gallons and forgets to dilute it seven times is a manufacturer of beer. There is no doubt but that thousands are and will be quite forgetful.

MRS. ELIZABETH POWELL BURIED IN GRESHAM

Mrs. Elizabeth Myers Powell whose death occurred near Boring on November 6, was buried from the Methodist Episcopal church yesterday. Rev. D. M. Cathey preached the funeral sermon. The interment was in the Gresham cemetery.

Mrs. Powell was born in Perry county, Pennsylvania, Feb. 19, 1833. She was married to Valentine Powell on April 6, 1851. There was born to this union eight children, five sons and three daughters. Of these three sons Ambrose, David and Daniel, survive. The two former live at Washougal, Wash.ington and were present at the funeral. Mrs. Powell's husband died in July, 1889.
