operated on and put to bed. Three days later I was put on an American Red Cross train and after a three-day ride arrived at the Base hospital in Bordeaux.

February 10, 1919. My dear Mother:—Received your welcome letter of January 18th tonight and was very glad to hear you were well. I am glad that the people at home understand and are doing something. Here are a few facts: coming out of the hospital and starting with two nights on frozen ground, with one blanket and a shelter half. Marching seven days under the supposition that we were on the way to a seaport. I was told so myself by an officer, told that if we fell out, (and hundreds did from sheer exhaustion, that we would be put in a labor battalion and kept over until the rest were back. Enlisted men were not allowed to talk to the nurses at Base No. 9 at Chatreau. Major Tasker in command. A Frenchman in this town said that an officer had prohibited his selling wood to us. He gave us some, and the weather bitterly cold, the officers have their wood brought in on trucks. These facts are absolutely true and I can vouch for or prove any one of them.

This leaves me well, and with hopes that I may be home for the Fourth of July, I will close. Your loving son, CURTIS.
