MAKES OBJECTION TO SCHOOL BONDS

Gresham, March 7.—To Editor Gresham Outlook.—Gresham has the horse hitched to the new school cart but the cart is before the horse.

There are three principal reasons why the cart went wrong. The first reason, The school if put in the wrong place as the present one is in the wrong place. The second, We could get along from three to five years with economy and common sense. The third reason, The public school must be overhauled and trimmed in a very short time.

The school at present. There are very few if any pupils coming from the south. On the east is the church and cemetery. On the west is a dairy farm, and on the north will be the Mt. Hood Loop, where our children go across the street are in constant danger of being run over. When you stand by the bedside of a mangled child or casket of a dead child, you will say, "Why didn't we know better?"

For the second reason, We could get along with the present school from three to five years. You have given us the present enrollment but not the average attendance. There seems to be just one overcrowded grade, and that is the second grade. There seems to be more or less room in all other grades up to the eighth. By the teachers using care and intelligence they could crowd the most intelligent pupils ahead, and what is the matter with the large assembly room in the old school? Couldn't it be used by one or two grades after the one assembly per week is over?

Is Gresham prepared to hire from sixteen to eighteen new teachers, hire janitor service, and general expense more than doubled? By intelligent care and cooperation we could get along until Gresham knows whether she will live or be strangled by non-tax paying bond voters.

Our public schools are at present the plaything of politics and sectarianism. The fight is on, and we don't know where the public school will come out. One thing is certain, the public school needs cleaning and trimming. It is only in its infancy and experimental age. Only by extreme care by the friends of the public school, by keeping it within taxable reason, and by working with the minority in harmony and dropping non-essential studies will it be able to survive.

There are so many misconceptions indicated in the above letter, and some erroneous statements, that the Outlook offers a few suggestions in reply.

The writer says Gresham has the Outlook but he evidently did not want it published. Why not? In offering such a criticism of public affairs through the newspaper why not let the reading public know who holds the views stated? What motive leads the writer to withhold his name?

The writer says Gresham has the cart before the horse. That is, somebody has bungled, the plan is untimely, or cannot be worked. But with reference to the entire criticism Exile has come along with his objections after the matter has been duly announced and decided, and plans are under way for carrying out the decision of the district. The vote was more than two to one in favor. And, in spite of Exile's uncertainty as to whether or not Gresham is going to live, there was not a non-tax paying vote cast at the school election.

The writer offers a severe and we think unwarranted criticism on the efficiency of the public school system in general. None will claim it is perfect. Its development in this country has been rather rapid and doubtless mistakes have been made. It must be overhauled and trimmed. "Is the plaything of politics and sectarianism," and "needs cleaning and trimming," says the writer. At the same time the writer admits it is only "in its infancy and experimental age."

The whole purpose of the letter seems to be the voicing by the writer of a protest against the enlargement of Gresham grade school facilities by the building of a new schoolhouse. He thinks the district could have gotten
