DAMASCUS COMMUNITY SHOW IMPROVEMENTS
Agricultural enterprises are on the increase in the Damascus community. The berry acreage is growing from season to season and dairying is making a notable gain. The following farmers are building silos this fall: Adam Bell, W. Weissenfuh, John Hillary and Martin Anderson. The Union Dairy from Vancouver, Washington, has leased the Garner farm and is milking 50 cows.
Damascus has moved one mile nearer to the pavement by the extension of the hard surfaced road from the Multnomah county line to Hemrich road, two miles from Damascus.
Henry Bock has purchased a new touring car from Lomie Lehman, salesman for Raker & Son.
The federal cow tester who has been working through this community found very few reactors. Martin Lehman lost two or three cows, Mr. Anderson, reuter on the Paulson farm, one, and Union Dairy several.
The regular meeting of the Damascus Farm Bureau held an interesting and profitable session Saturday evening, October 6. S. B. Hall, Multnomah county farm agent, gave a splendid talk on marketing potatoes. He told the story of the inception and passage of the potato grading law which went into effect on September 15 and called attention to some of the sure benefits of the law. This law will standardize potatoes and protect the home market. The grading and inspection of potatoes, said Mr. Hall, will prevent the dumping of culls on the market. Portland has been known as a cull potato market. The potato grading law has for the first time put Portland on the same footing as other market cities.
The committee appointed to take steps toward the prevention of sport hunters in the fields and the dumping of rubbish reported at length on what steps had been taken. G. F. Peterson is prepared to supply members with "no trespassing" signs.
A fine program of music and readings was greatly enjoyed, as well as the refreshments and the eating contest, in which the winner, Edward Schwedler, received "a dime and stick pin."
Damascus Farm Bureau people are proud of the fact that the first carload of potatoes inspected and passed under the new potato grading law by the state official cooperating with the U. S. department of agriculture was shipped from Boring and the potatoes were grown by farmers of the Union district, E. Bartel, Herman Johnson and John Anderson. The grade was U. S. No. 1 and the destination Stockton, California.
Oran Lingle won a blue ribbon on his exhibit of American Wonders at the state fair.

\$500,000.00 Multnomah County, Oregon, Burnside Street Bridge Coupon Bonds.
Notice is hereby given that the Board of County Commissioners of Multnomah County, Oregon, will receive sealed bids for an issue of coupon bonds for \$500,000.00 of the tenor as follows:
Bonds shall be dated November 1st, 1923, and shall bear interest at the rate of not more than five per cent. per annum, payable semi-annually. The rate of interest which said bonds shall bear has not been specified, but each bidder shall offer to buy said bonds must specify in his bid the rate of interest to be paid thereon, and the rate of interest so specified by the bidder will be taken into consideration by the Board of County Commissioners in selling the bonds, and the Board of County Commissioners will determine the rate of interest to be paid.
These bonds shall be issued in denominations of \$1,000.00 each; principal and interest to be paid in gold coin, at the Fiscal Agency of the State of Oregon, in New York City, N. Y., or at the office of the Treasurer of Multnomah County, Portland, Oregon, and said bonds will mature as follows: \$25,000.00 November 1st, 1929, and \$20,000.00 on the first day of November of each and every year thereafter until the entire series of said issue shall have been paid, to-wit: November 1st, 1953.
These bonds are issued for the purpose of raising funds to construct a bridge to replace the present Burnside Street Bridge over the Willamette River, in the City of Portland, Oregon, and have been authorized by an act of the Legislature of the State of Oregon.
A duly certified check, drawn on a responsible bank, for five per cent. of the amount of the bid, payable to Jos. W. Beveridge, County Clerk of Multnomah County, Oregon, must accompany each bid; such deposit is to be returned if the bid is not accepted, otherwise to be applied by the county on the sum so bid; if the bidder fails to comply with the terms of his bid, said amount shall be forfeited to the county as and for liquidated damages. Unconditional bids only will be considered. Bonds will be sold for cash only. No bid for less than par value and accrued interest will be considered. The bonds may be sold to the highest bidder, but the right is reserved to reject any and all bids.
All bonds which may be sold under this issue shall be sold for delivery at such bank at Portland, Oregon, as may be designated by the successful bidder.
The successful bidder will be furnished with an unqualified and final opinion of Messrs. Storey, Thornöyke, Palmer & Dodge, of Boston, Mass., approving the legality of the issue.
