CROWDS ATTEND LAYING
OF FAIR BUILDING STONE

The formality of laying the cornerstone of the first of a group of buildings to be erected by the Multnomah County Fair association on its 51 acres of land here was duly observed Saturday afternoon when approximately a thousand persons gathered in the grandstand and enjoyed a varied program which concluded with the winding of the May pole by 26 pupils of the Gresham grade school. Erwin A. Taft, county commissioner, deposited a trowel full of mortar on the site of the tablet marking the cornerstone, which bore the inscription, "Multnomah County Fair, Erected 1926."

Streamers of flags were strung across Main street in Gresham, lending a festive air of holiday attire to the town. The weather was as near perfect as weather could be and a representative gathering from all parts of the county visited and chatted under the protecting roof of the grandstand. A truck, ornamented with the national colors, backed up in front of the stand, and this formed an improvised speakers' stand for the afternoon.

T. J. Kreuder, president of the fair association, was in charge of the exercises of the day, later turning over his chair to Joe Dunne, a director of the fair and a candidate for state senator, who was initiated as master of ceremonies and who kept his audience in a good humor by his sallies of wit at the expense of the political aspirants which, by the way, were as plentiful as smelt in the Sandy. Fire Chief Holden's Toonerville firemen's band came out from Portland to furnish the fun for the occasion and their ludicrous antics were a constant source of amusement. Chief Holden was formally introduced to the audience.

Governor Walter Pierce was unable to be present, as important business called him to eastern Oregon, but he was personally represented by H. R. Blauvelt who paid a fine tribute to the rugged personality of the governor of Oregon. Mr. Blauvelt spoke briefly on the subject of agriculture, designating it as the greatest industry in the United States and the investment amounting to more than eighty billion of dollars.

Erwin A. Taft represented the board of county commissioners and gave a short address which was followed by a rousing yell by the school children, beginning, "What's the matter with Mr. Taft?" Admirers of the county sheriff, Tom Hurlburt, had the pleasure of having him pointed out. Mr. Hurlburt acknowledged his introduction by rising and bowing to the audience. The officials of the band were introduced, also the visiting mayors, A. L. Barbur, representing Mayor Baker of Portland, Mrs. Laura Harlow, of Troutdale, Mayor Heslin, of Fair-

Candidate for nomination to succeed himself from the Third Congressional District.

PROMINENT ATTORNEY
SEEKS JUDGESHIP

Frank C. Howell, former member of the legislature and a lawyer of Portland, is a candidate for the republican nomination for Circuit Judge, Department No. 4, of the Multnomah county bench.

Mr. Howell has been a resident of Portland since he was graduated from the law department of the University of Missouri in 1909. He was born July 4, 1877, in Missouri, and was brought up on a farm, where he lived until he was 21 years old.

Mr. Howell received his B. A. degree in 1906 from Knox College in Illinois and graduated from the law department of the University of Missouri in 1909; came to Portland during that year and joined the law firm of Wilbur & Spencer and is now a member of the firm of Wilbur, Beckett, Howell & Oppenheimer. In 1918 he was elected to the Oregon state senate to fill an unexpired term.

Mr. Howell has a wife and one daughter. He has been urged to enter the primary race for the judicial nomination by a large number of fellow attorneys. He is a member of the Phi Delta Theta and Phi Delta Phi fraternities, Masons, Elks, W. O. W., Moose, Multnomah Club and Progressive Business Men's club.

View and Mayor Cowell, of Milwaukee, were gracefully introduced by Mayor Charles Cleveland, of Gresham. Mayor Cleveland gave a short review of the racetrack history of the county. Judge William Ekwall, that terror to speeders, said he recognized several of his customers in the audience, but agreed not to call out any names. Political candidates were introduced in turn to the audience and reminded their hearers in persuasive tones not to forget to remember.

As usual the Gresham band outdid itself by its excellent playing and fine range of selections. At the beginning of the program the strains of the "Star Spangled Banner" brought the audience to its feet and much appreciation was expressed by the master of ceremonies for the presence of the band.

The real hit of the afternoon was, after all, the children. They were there in costumes, the hues of which even a rainbow might well envy. Twenty girls executed most gracefully the parasol dance; the sunshine dance by 18 little girls was splendid; the scarf dance was another fine piece of drill work and the minuet by 16 older boys and girls in costumes of Washington's day showed the result of careful training. A fifth number by the pupils of the Gresham grade school was the winding of the May pole.

Much disappointment was expressed by many of the audience who were not apprised of the time when the laying of the cornerstone took place. A small number only witnessed this ceremony, mainly the members of the board of directors, but it was announced by Mr. Kreuder that this arrangement was unavoidable, as a moving picture machine operator was obliged to leave before the conclusion of the program in the grandstand and wished to take pictures of the ceremony before going to Portland. The management said it was possible another formal ceremony would be observed some time prior to the opening of the fair.

The building, for which plans have been drawn and which will be carried forward to completion as rapidly as possible, will cost around \$17,000 and will house the agricultural and horticultural exhibits of the fair. It will be of hollow tile construction, finished in stucco. The erection of this building was made possible through the levying of 1-29 of a mill tax, distributed among the taxpayers of the county.

KEEP CRUMPACKER IN CONGRESS

It is the bane of our primary system that the man seeks the office instead of the office seeking the man. Every election time a fresh crop of office seekers tries to oust the man who has served creditably and whose life and actions not only afford no adequate reason for a change but rather give every evidence of fidelity and effectiveness.

Maurice E. Crumpacker, of Portland, was elected in November 1924, from the third district, which comprises Multnomah county, and has served only one short term in congress. He is a young man, a capable lawyer, a ready and convincing speaker, and has been well received. He has been industrious, safe, and has shown ability as a legislator.

There is no criticism of Crumpacker except that implied in the old insinuating question, "What has he done?" That is only a campaign smoke screen thrown out by an opponent who, there is no reason to believe, could have done any better had he been in the incumbent's place.

Why sacrifice an honest, industrious, capable man, who has been in just long enough to get acquainted, to be in line for promotion, and to begin to render the most efficient service to his state and district, for a new and untried man who, whatever his capabilities, will need to go through the same experience of initiation?

Crumpacker has been acceptable to his district and state. He has been particularly fortunate in being assigned to one of the major committees, the rivers and harbors committee, which puts him in a position to do more for Portland and Oregon than any other assignment. He has made close friendships with the republican leaders and with the speaker of the house.

Crumpacker is on the job. There is important legislation pending affecting Multnomah county which necessitates his continued presence in Washington, hence he will not be home to promote his campaign for renomination. He depends upon his friends, if they believe in him, to do that for him. That is the least they can do and that they should do.

Opposed to him on the republican ticket for the May primaries are B. F. Mulkey and Norman Richards. Both are lawyers of Portland. Richards is a wet. Mr. Mulkey is an estimable gentleman and a pronounced dry. But so is Crumpacker.

Congressman Crumpacker's position on the prohibition question is clearly expressed in the following statement:

"I believe in strengthening the Volstead act in order to bolster up and make more effective the enforcement of the prohibition law of this country."

"The people of Oregon have spoken upon this question, sometime prior to the enactment of the eighteenth amendment to the federal constitution. With this law upon the statute books in the state of Oregon, it is my conception of the duty of a representative in congress from this state to express the sentiments of his constituents by using his efforts to strengthen the national prohibition law."

"No influence, however powerful, can dissuade me from this position. I want that clearly and emphatically understood."

This statement was made two years ago and in answer to a recent letter was reiterated and positively confirmed as his present position. Could anything be clearer on this point? These statements are on file in the Outlook office.

The Oregon Voter, in the May 1 issue, under the editorial caption, "Don't Forget Crumpacker," says there are no obvious advantages in or reasons for replacing Crumpacker with Mulkey.

"In his membership on the rivers and harbors committee of the house, and in his close alliance with the powers that be in that body, including Speaker Longworth, Crumpacker is in command of a strategic influence."

"It is idle to imagine that either of Crumpacker's two opponents could so quickly command the influence that is now at his command. And Crumpacker is wise enough and sufficiently well-advised to know that though he won his influence through his personality, he must maintain it through a display of energy and intellect."

"A strong vote for Congressman Crumpacker at this time would have the effect of strengthening whatever position he takes as a representative from Oregon on the House committee which passes upon rivers and harbors legislation. Without a strong endorsement his effectiveness during the present session would be minimized. To fail to re-nominate him would be a serious mistake. Portland needs the protection against pernicious port legislation that Congressman Crumpacker can give it."

"Don't swap horses in the middle of the Willamette river while the interests of that river are at stake."

The close analysis, fairness and sound judgment of C. C. Chapman of the Oregon Voter in sizing up candidates and issues cannot be questioned.

Therefore, every republican voter in Multnomah county should adopt the slogan, "Keep Crumpacker in congress," and vote on May 21 accordingly.

Assistant attorney general from 1915 to 1920 in charge of Hyde-Benson and Pacific Livestock Land Fraud cases and Columbia River Basin rate case. Member of 1925 legislature. Member for past five years of the Grievance committee, State Bar association. Chairman past two years of Magazine committee, Oregon Parent-Teacher. As assistant attorney general under Hon. George M. Brown, he conducted, to a successful conclusion, the Hyde-Benson and Pacific Livestock Land Fraud cases, recovering for the state more than \$160,000 in settlements and approximately 15,000 acres of land appraised at more than \$500,000, at a cost to the state of less than \$10,000; and also represented the state in the Columbia River Basin Rate case which resulted in Portland procuring a ten per cent lower freight rate than Puget Sound and from the territory south of the Snake river.

The chapel of the Gresham Funeral parlors has recently been completed, and the manager, J. E.
