GRESHAM WOMAN DIES AFTER LONG ILLNESS

Mrs. J. F. Barnes, who suffered a paralytic stroke last May at her home in Gresham, passed away Friday afternoon, October 8, at the Thomas sanitarium, aged nearly 54 years.

Funeral services, which were in the hands of the Gates Funeral Home, were held from the Methodist Episcopal church yesterday afternoon, when the Rev. A. H. Thompson, pastor of Epworth Methodist Episcopal church of Portland, preached the sermon.

Interment was in Lincoln Memorial Park, formerly Mt. Scott cemetery. The pall bearers were Sam Morrison of Seattle, Chas. Brown of Portland, L. L. Kidder, C. E. Rusher, C. A. Rogers and C. N. Taber.

Harriet Julia Pettijohn was born in Shakopee, Minnesota, November 18, 1872. She was the youngest daughter of Eli Pettijohn, who came from Illinois to Fort Sibley, later St. Paul, in 1851 as a school teacher and music teacher in the Presbyterian mission at that place, and who became a leader in the development of milling and other pioneer enterprises.

AN APPEAL TO VOTERS

We may have our party preferences. Partisanship isn't the crying menace of this country. It's the absence of the right kind that makes the voters apathetic.

For District Attorney

The office of district attorney is one of vital importance to the people of Multnomah county. He is not only the public prosecutor but the legal adviser for the various departments of the county government, and on his shoulders falls the duty of strictly enforcing the laws which the voters, through the state legislature, have placed on the statute books.

The district attorney has ample machinery for enforcing the law. When he calls upon the governor to assign a special prosecutor from the office of the attorney general it strongly hints of either a lack of ability on his part or an admission that he is so enmeshed with the element he has taken an oath to prosecute, that he dare not, for his personal protection, take any action.

Clifford G. Schneider has no political debts to pay and is not involved in any entanglements which could in any way be used to compel him to compromise himself, or step aside from a path of strict law enforcement.

A custom, for which no good reason can be found, seems to have become established in Multnomah county that the district attorney should take little or no part in trial work but leave this duty entirely to a force of overworked and underpaid deputies.

Whether this custom has developed as a result of a lack of energy, ability, or other cause, is beside the question. The fact is that the taxpayers' money pays his salary and he should give a dollar's worth of service for every dollar received, and part, at least, of that service should be given by taking his place at the trial table.

Mr. Schneider, as district attorney, promises to assume the duties of that office and to so conduct the office that it will be unnecessary to ask for the assignment of special prosecutors from the office of the attorney general and to "take his place at the trial table" with his deputies.

Mr. Schneider will vigorously oppose giving the press advance information of investigations before submission to the grand jury as was done in the recent "yellow ticket" affair.

Under our statutes the grand jury should not be hampered in any manner in their investigations, but on the contrary should be encouraged and assisted in every way possible by the district attorney, in inquiring into anything that savors of a violation of the criminal laws, and this Mr. Schneider says as district attorney he will insist upon.

Another phase of the situation is that a little self-denial is good for the average human and if the children do have to "double up" for a few nights or some member of the family be ousted to another room, the effort will be well repaid.

It is necessary that the people of the community respond more freely in the matter of providing sleeping quarters and if those in the country who have machines could plan to provide a room and convey the delegates to and from the church, this would also help meet the situation.

The ladies of the Baptist church are planning to serve luncheon to the delegation on Wednesday, the Methodist ladies on Thursday noon and the ladies of the Auxiliary to the Legion on Thursday evening.
