G. U. H. S. Boy Wins Alternate Scholarship

John Welbes, alternate in the Oregon State College scholarship recently awarded by the Union Pacific Railway company for Multnomah county, in the following interesting story tells of his varied experiences in club work which began when he was but nine years old.

When I was nine years old Miss Ethel Calkins, the county club agent for Multnomah county, came to organize 4-H clubs in the school which I was attending. I had no intention of joining a club, but she talked me into enrolling in garden club work. I am glad I did, for it was my little garden that didn't amount to much that started me in club work.

My father gave me a piece of ground and plowed and harrowed it for me. I bought about 12 different kinds of seeds and put them in. It was hot working that summer, but I got enough to exhibit at the Multnomah county fair. I did not get a premium but went home feeling I would do better next year.

The second year in club work I took up the corn raising project. I planted an acre of yellow bantam corn. It was planted so that it could be cultivated both ways. I sold the corn that we did not use for our own use to our grocery store and the stalks to my father to feed his cows.

This year I am a sophomore in high school, but I am still going to keep up my club work. My gift from last year had a nice litter of eight pigs. I sold two, but I will keep six so I can have a pen of four, gilt and a barrow for show purpose this fall.

My club work success has not all been due to luck as I have worked hard and I have had some wonderful leaders. Miss Ethel Calkins was my first and Bill Kinder my second, and I never called on them but what they responded. I hated to see Miss Calkins go, then when Mr. Kinder went to Idaho that was almost more than we could stand, but we have a good leader now in Bill Baillie and hope he will stay with us.

My father and mother also have backed me to the limit in my work. Just as an illustration I might say that when I first started with my pig club work dad took him to the fair in a crate on one of the running boards of the old Ford and the second year he had one on each side. Now he has to have a truck to haul pigs, calves and chickens so you see we have all worked together. We have learned to face disappointment as well as pleasure.

We were very glad and happy to learn that I had been selected as an alternate for the Union Pacific scholarship, and although it is just an alternate, it is an honor and I am out now to win the chance for the same prize on my own.

Fredolf Backlund Is Instantly Killed

Fredolf Backlund, 26-year-old son of Mr. and Mrs. J. H. Backlund of Haley, was instantly killed Saturday afternoon when the car in which he was riding with Lewis Lake, Boise, Idaho, overturned near Celilo on the old Oregon Trail highway, 10 miles east of The Dalles at 4 o'clock Saturday afternoon.

An unidentified man, whom Lake had picked up along the highway and was taking to Boise to look for work, was also killed. Lake, who was not seriously injured, attributed the accident to loose gravel which the car struck while traveling at a good speed.

Besides his parents, Mr. Backlund is survived by a brother Harold of Portland and two sisters, Mrs. Herbert Olson and Mrs. August Leckburg, both of Haley.

Funeral services were held this afternoon at the Haley Baptist church with interment following in Douglas cemetery under the direction of the Gates Funeral Home. The body was taken to The Dalles by the coroner after the accident. J. E. Gates drove to The Dalles Sunday and returned with the body.

The unfortunate young man was a former student in Gresham Union high school. For the past two years he had been employed in Portland, but recently made plans to go to Idaho for work. He was virtually a stranger to Lake, with whom he was riding.

CORBETT MAY LEAD STATE SENATE LIST



Harry L. Corbett

Unless all prospects fail and precedent is reversed, Senator Harry L. Corbett will lead the state senate nominations on the republican ticket for this district. He is president of the state senate and is a candidate to succeed himself. He is influential, inspires confidence and his record is excellent.

Senator Corbett has served as a member of the upper house of the Oregon legislature for a number of years and presided over that body during the 1927 session. By virtue of being president, he is, until the next legislature assembles, successor to the governor in the event of the incapacity or absence of Governor Patterson.

An ex-president of the Portland Chamber of Commerce, Senator Corbett has long been identified with the growth and development of Portland and of the state at large. As a member of the state senate, his record is one of conservation and in opposition to proposed freak laws. When he was a candidate four years ago, Senator Corbett led the ticket, receiving an exceptionally high vote.

As president of the senate he did not have a "program" to put through, nor did he attempt to direct legislation through an "organization" as is generally the case with presiding officers. In announcing himself for re-nomination and election, Senator Corbett is following the urging of a number of delegations which have requested him to return to the senate.
