**COLUMBIA BASIN ALFALFA  
GROWERS ASSOC'N ORGANIZED**

(Continued from page one)

**By-Laws**  
Columbia Basin Alfalfa Growers As-  
sociation.

**Article 1—Name**  
This Association shall be known as  
the Columbia Basin Alfalfa Growers  
Association, and shall be incorporat-  
ed under the laws of the state of  
Oregon. Its principal office shall be  
located in the city of Hermiston,  
State of Oregon.

**Article 2—Object**  
The objects of this organization  
shall be to promote the development  
of the most profitable system of alf-  
alfa production and marketing. In  
carrying out these objects the or-  
ganization seeks the cooperation of  
the County Farm Bureau.

**Article 3—Program of Work**  
The objects of this organization  
shall be effected through the adop-  
tion and promotion of a definite pro-  
gram of work. It shall be formul-  
ated and carried out by the officers  
and members of the organization  
with such assistance from the county  
agents and specialists of the State  
Agricultural College as may be avail-  
able.

**Article 4—Membership**  
**Section 1—Membership**—Any alf-  
alfa grower interested in the objects  
of this organization may become a  
member by paying a membership fee.

**Section 2—Fees and Dues**—A min-  
imum annual fee of \$1.00 shall be  
charged for active membership in  
this organization. Provided that if  
the alfalfa grower is not already a  
member of the County Farm Bureau  
an additional amount equal to the  
Farm Bureau membership fee shall  
be collected and turned over to the  
County Farm Bureau treasurer of the  
county in which he resides.

**Section 3—Every member shall be**  
entitled to one vote and no proxy  
votes shall be permitted.

**Article 5—Officers**  
The officers of this organization  
shall be a president, a vice-president,  
and a secretary-treasurer, all of  
whom shall be elected for a period of  
one year by the members present at  
the annual meetings and shall serve  
until their successors are elected and  
qualify.

**Article 6—Board of Directors**  
**Section 1**—The board of directors  
shall consist of the president and  
secretary-treasurer, ex-officio mem-  
bers and one member from each alf-  
alfa growing community recognized  
by vote of the members at any gen-  
eral association meeting or by vote  
of the board of directors. Each  
member of the board of directors  
shall be elected annually by the mem-  
bers of the association residing in an  
alfalfa growing community, recog-  
nized as provided for above who may  
be present at the annual meeting to  
serve one year or until his successor  
is elected. With the adoption of  
these by-laws the following districts  
shall be recognized: Echo, Umatilla,  
Meadows, Stanfield, Irrigon, Board-  
man, Butter Creek, Hermiston, Col-  
umbia.

**Section 2**—When the number of  
members of the board of directors  
shall become more than 11, an ex-  
ecutive committee consisting of the  
president and secretary-treasurer, of  
the Association and three members  
elected from the board by the board  
to serve for one year, shall be chosen  
to transact such business as may  
be delegated by the board of directors  
to the executive committee.

**Article 7—Community Committees**  
The president of the organization  
in consultation with the board of di-  
rectors or upon recommendation of  
the members in each community shall  
appoint for each community a com-  
mittee of two to carry out the work  
of the organization in the commu-  
nity. The member of the board of di-  
rectors selected from each community  
shall serve as chairman of the com-  
munity committee.

**Article 9—Duties of Officers and  
Committees**

**Section 1—President**—The presi-  
dent shall perform such duties as  
usually pertain to the office of presi-  
dent; shall upon approval of the  
board of directors have the power to  
fill such vacancies as may occur in  
any office or committee; shall pre-  
side at all annual and special gen-  
eral meetings of the members and  
meetings of the board of directors  
and executive committee; shall make  
requisition on the secretary-treasurer  
for such sums of money as may be  
required for disbursement; may call  
special meetings of the members of  
the organization or any of the com-  
mittees whenever he deems it advis-  
able; upon the application in writing  
of any 10 members of the organiza-  
tion he shall call special meetings of  
the members; shall appoint members  
of the community committees as here-  
in before provided for; and may ap-  
point special committees provided  
such work cannot be handled by the  
regular constituted committees.  
The president will be supported for  
a place upon the executive committee  
of the Farm Bureau of the county in

which he resides.  
**Section 2—The Vice-President**—  
The vice-president shall perform the  
duties of the president in case of his  
absence or disability.

**Section 3—Secretary-Treasurer**—  
The secretary-treasurer shall perform  
such duties as usually pertain to the  
office; shall keep a record of all  
meetings except community meetings  
and of the transactions of this as-  
sociation; shall give written notices  
of all meetings of the organization  
and its committees; shall have  
charge of all funds of this organiza-  
tion; shall deposit them in such bank  
as the board of directors shall direct;  
shall upon written requisition of the  
president draw all checks and vouch-  
ers for the disbursement of funds for  
this organization and shall make  
such reports and give such bond as  
the board of directors may direct;  
the cost of this bond shall be paid  
by the organization.

**Section 4—Board of Directors**—  
The board of directors shall transact  
the ordinary business of the organiza-  
tion and approve all contracts and  
bills. It shall annually consider the  
recommendation of the members and  
the community committees and with  
the assistance of the county agents  
develop, adopt and promote a definite  
program of work. Each year it shall  
organize and direct the membership  
campaign; it shall perform such other  
functions as may be necessary  
for effectively carrying on the work  
of the organization.

**Section 5—Community Committees**  
—The community committees shall  
represent the association in their re-  
spective communities; it shall carry  
on such work as the board of direc-  
tors may direct; it shall secure local  
memberships for the organization.  
The chairman of each community  
will be supported for membership up-  
on the Farm Bureau community com-  
mittee.

**Article 10—Remuneration**  
**Section 1**—All officers and com-  
mitteemen shall serve without re-  
muneration. The expense necessary  
to carry out any given project shall  
be born by those members deriving  
direct benefit.

**Article 11—Meetings**  
**Section 1—Annual Meetings**—The  
annual meeting of the members of  
the organization shall be held upon  
the first Thursday of May each year.  
Special meetings may be called by the  
president whenever necessary and  
shall be called by him when demand  
is made in writing by any 10 mem-  
bers.

**Section 2**—The board of directors  
shall hold regular monthly meetings  
the first Thursday of each month. On  
the majority vote of the board a reg-  
ular meeting may be omitted or post-  
poned. Special meetings may be called  
by the president whenever neces-  
sary and shall be called by him when  
requested to do so by three members  
of the board.

**Section 3—Community Committees**  
—The chairman of a community  
committee may call meetings of the  
committee at such times and places  
as may be advisable. The secretary  
of the community committees shall  
notify all members of the committee.

**Article 12**  
The action of members at the an-  
nual meeting or at special meetings  
of the association, when supported  
by a two-thirds vote of members pre-  
sent and when notice of such proposed  
action shall have been given in the  
notice of the meeting shall be bind-  
ing upon all members.

**Article 13—Quorum**  
Ten percent of the membership,  
provided that a majority of the com-  
munities represented shall consti-  
tute a quorum. Five members of the  
board of directors shall constitute a  
quorum.

**Article 14—Order of Business**  
1—Call to order by the president.  
2—Reading minutes of previous  
meeting.  
3—Report of secretary-treasurer.  
4—Reports of committees.  
5—Unfinished business.  
6—New business.  
7—Adjournment.

**Article 15—Amendments**  
These by-laws may be altered or  
amended by a two-thirds vote of the  
members of the association present  
at any regular meeting or at a special  
meeting called by the request of  
10 members. Notices in writing of  
the proposed changes having been  
given to all members of the associa-  
tion at least one week previous to  
the time of meeting.

**A DAY WITH SENATOR HARDING**

**Calm, Steady, Determined, the American Who is Leading  
the Republican Party to Victory Goes About the Busi-  
ness of the Campaign in His Modest Office in Marion.**

The American people will decide,  
of course. If they can visualize the  
vital principle which is at stake—the  
spirit which is at once the keynote  
and the mainspring of the campaign  
upon which the nation has entered,  
there can be no doubt of the result.  
It isn't a thing that can be carried  
about the country, and exhibited from  
the rear end of a Pullman car. It is  
wholly apart from the red fire, blar-  
ning bands and stump oratory of old-  
fashioned campaigns. The issue, in  
short, goes deep down to that princi-  
ple which has been the mainspring of  
the national life since the days of Lex-  
ington and Concord; and the patriotic  
citizen, Republican and Democrat  
alike, by taking counsel with himself,  
will find it imbedded in his own heart.

Here in Marion, O., you get a con-  
crete exposition of that vital princi-  
ple. It is good to come to Marion and  
get the true perspective. You are  
brought anew, here, to the realization  
that the country is in process of elect-  
ing a chief executive to guide the des-  
tinies of 120,000,000 people for March 4  
next; that the very serious business of  
bringing about what a European ob-  
server described as "a revolution by  
due process of law," is going forward  
with a proper regard for the dignity  
and importance of the task.

**Scene Entirely Appropriate.**

Your first impression is of the firm-  
ness of Marion as the scene for the  
enactment of such a chapter in Amer-  
ican history. It is a quiet little coun-  
try town, for all its boasted industrial  
activity; and when you approach the  
Harding residence, one among many  
in its simplicity and attractiveness,  
you feel that from this typical American  
home there should come a modest, dig-  
nified and capable, up-standing Ameri-  
can upon whom the choice of his fel-  
low citizens should fall to uphold the  
honor and traditions of the nation.  
This conviction grows when you meet  
the man. He is typical of the success-  
ful business man—of the hundreds of  
thousands of successful Americans  
who have accumulated a competence  
through the ordinary channels which  
are open to all hard working, straight-  
forward American boys.

Meet him, now. He has established  
an office in the home of George Chris-  
tian, Jr., his secretary, which adjoins  
the Harding house—and this is typi-  
cal; chief and secretary live side by  
side, each owning his own modest  
home. And by the way, these ex-  
ecutive offices are illuminating as to  
the kind of a man it is whom the Re-  
publican party has made its standard  
bearer in this epoch-making campaign.  
Every room in the house is given over  
to the business in hand—the senator's  
conference room is the Christian din-  
ing room, his private office, where the  
important conferences are held, is the  
kitchen. In the living room sits Chris-  
tian. Elsewhere, from cellar to gar-  
ret, the staff are at work. No confu-  
sion, no disorder, no hectic shouting  
at the top of one's voice, no running  
around in circles, pounding of the  
table, no flustering, Jimmying or Billy-  
ing, with strident denunciations of  
the other side, and loud boastings of  
the way the opposition candidate is  
to be beaten into a pulp. Just a thor-  
ough, careful, business-like transac-  
tion of the business in hand—precisely  
the way in which we like to think the  
work of 120,000,000 people will be con-  
ducted at the White House after  
March 4.

Step into the dining room and meet  
the senator. Just at the minute he is  
reading proof on editorials which are  
to be printed in his newspaper, the  
Marion "Star," in the afternoon. The  
senator stands for everything that is  
printed in the "Star," and is careful  
to read what goes into its columns be-  
fore the paper goes to press. Dispos-  
ing of the proof sheet, he shakes  
hands cordially with you, and you are  
at liberty to size him up.

**Mark Him Dependable.**

He is somewhat above the average,  
of course, because he has already been  
singled out by the people of Ohio to  
represent them in the senate. But  
aside from this: You are at once  
struck by his balance and his poise.  
You mark him as dependable—safe.  
There is that in his face, on his brow,  
which gives assurance that he is not  
the sort of a man who will speak with-  
out thinking, or act without delibera-  
ting. There is reserve force in his  
bearing, determination in his law,  
character in his mouth, kindly sym-  
pathy in his eyes.

As you listen to him talk here in  
the Christian dining room, or later, in  
a speech to a visiting delegation from  
the front porch of his home, this con-  
viction is strengthened. He doesn't say  
anything in his office that he wouldn't  
say out on the porch, nor anything on  
the porch that he wouldn't adhere to  
in all sincerity in his office.

The thing that strikes you at all  
times—it is the very atmosphere of  
Marion—is his moderation, his re-  
straint—the absence of all bombast  
and exaggeration in his statements,  
the careful presentation of the issues,  
the avoidance of all attempt to array  
one class against the other, the con-  
veyance of the desire, if called to the  
presidency, to be president of all the  
people; and, without making any high-  
sounding promises, to give all of the  
people the best that is in him.

**Avoids Personal Controversy.**

Particularly noticeable is his avoid-  
ance of personal controversy. Not  
once since his nomination has Hard-  
ing referred in a public speech to his  
opponent. He adheres to the issues.  
Not once has he permitted himself to  
indulge in personal denunciation of  
his rival.

He is sane. He has fixed con-  
victions as to the moderation and bal-  
ance which should characterize candi-  
dates for the high office of the presi-  
dency; departure from which he be-  
lieves, without doing any good to the  
candidate who offends, does serve to  
bring American institutions into con-  
tempt.

During the war there was a Hard-  
ing-kind of man in service as bosun  
on an American merchantman. The  
time came when the ship was ter-  
rified; and the bosun was put in  
charge of the tiller of the whaleboat  
in which a goodly portion of the crew  
took refuge. A storm arose, and there  
was imminent danger that the boat  
would be swamped. In the stress  
sheets sat the bosun, rigid and erect,  
his hand locked to the tiller. He said  
little—"Steady!" now and then to the  
rowers; or "hold fast; take her head  
on!" as the boat rose on the crest of a  
giant wave, and then plunged straight  
down into the trough of the sea. For  
twenty-three hours straight-away,  
he held fast to the tiller, and he didn't  
relinquish it until he had guided the  
boat hard and fast on a friendly beach.

Then he got up and stretched and  
asked for a pipe of tobacco.  
Calm, steady, determined and know-  
ing his business, one conceives of  
the other Harding thus guiding the  
ship through any storm that may  
arise, to a safe harbor.
