CITY IRRIGATION WATER ASSESSMENT FOR 1924.

DISTRICT No. 1
Notice is hereby given that in accordance with Ordinance No. 76 of the City of Hermiston, an assessment has been levied upon and against the following lots and parcels of land in the Irrigation District heretofore established in the City of Hermiston in the amounts set forth below.

The total amount of assessment in said Irrigation District is \$1695.00. The contract price to be paid the United States Government for water for the irrigation in said District is \$1.50 per acre for two acre feet and fifty cents per acre foot for all water in excess of two acre feet.
