HERMISTON TRIUMPHS OVER KENNEWICK

GRALAPP'S PRODIGES DISPLAY UNUSUAL FORM

The Local Boys Will Journey to Walla Walla Next Saturday to Meet on The Gridiron the High School Team of That City

Hermiston high school opened the football season here last Saturday by defeating Kennewick 20 to 3.

After Kennewick had received the kick-off things began to look dark for Hermiston high. For the first three or four downs the visitors made gains through the lines and around the ends. But after a few minutes of this Hermiston's line tightened and Kennewick found a line that could be likened to a stone wall facing them.

Hermiston's first touchdown came in the first quarter. They had carried the ball down the field by downs and were only a short distance from the goal line when a forward pass was instrumental in them putting it over. Attempt to kick goal failed. From this time until the end of the first half nothing real exciting happened, the ball being in the possession of one side or the other through failure to make downs on account of fumbles.

When the Kennewick team romped on the field for the second half there was blood in their eyes but the best they could do was to take their downs, and kick out of the danger zone on the last.

Hermiston put the ball over in the third quarter for another score. In this quarter Kennewick managed to get the pigskin on the thirty yard line and elected to try for a kick. The ball left the toe of the Kennewick booter and sailed over her cross piece for a place kick. In the fourth quarter Hermiston made their third touchdown. For an early season game the local boys played good football.

Gralapp has a fast team this year and with a little more seasoning should be able to carry off a big share of the football honors in this neck of the woods.

The team goes to Walla Walla Saturday to meet the high school team of that city.

A Communication

A week ago Monday in the city of Hermiston, Marion Howard, a thirteen year old eighth grade boy narrowly escaped death at the hands of two high school boys, Dick Thomas and Leslie Lomax. Young Howard was standing on the street and was lassoed by the boys. He succeeded in getting the noose off once and Lomax threw the rope over his head again. Dick Thomas then set spurs to his horse with two loops around the saddle horn. The boy was dragged in the gravel up Main street on the highway, knocked unconscious, teeth torn from his left shoulder and hand, his head striking the ground causing an ugly wound above the left eye. It was this blow that caused him to lose consciousness. He was dragged across the highway before the rope could be freed from his body and left in the pathway of a California touring car. The driver saw the boy in time to swerve to one side nearly upsetting his car. The man was so infuriated that he immediately set out in pursuit of the Thomas boy but he eluded him on the many cross-roads leading to Hermiston. Mr. Challis, a business man, carried the unconscious boy to a nearby hotel where he regained consciousness. A doctor was summoned and he was properly attended to. He is recovering well enough except for a slight infection above his eye.

Thomas and Lomax immediately dispatched themselves to the injured boys home and begged for leniency, saying they were sorry and meant no harm. The matter was settled by them paying the costs connected with the boy's injuries.

DAIRY AND HOG SHOW PROMISE FINE EXHIBIT

BIG INCREASE IN STOCK EXHIBITS IS ANNOUNCED

Boys and Girls Clubs Will Have Interesting Part in Show. Business Men of Pendleton Will Send a Delegation

The Dairy and Hog show which will be held Friday and Saturday, October 10 and 11, promises to be the greatest Hermiston Dairy and Hog show ever held here since its foundation 12 years ago. More general interest is shown. The board is more active, the exhibitors will excel in numbers by 100 percent and the sports and entertainment and fun will be much more in keeping with our annual gala day of the west end of Umatilla county. The Pendleton commercial club has a committee at work working up a crowd from the Roundup city which is greatly interested in diversified farming and desires to pat the promoters of this kind of agriculture on the back. Pilot Rock and Freewater will be here with exhibits and judging teams. County Agent Bennion will have a finer display and greater interest in the boys and girls club work. The attendance this year is expected by the board of directors to exceed previous attendance by several hundred.

The president of the board, Mr. Stillings, promises a wonderful exhibit of swine from numerous exhibitors and he is working every day toward a general farm display.

A. W. Agnew, superintendent of dairy cattle, has his work well in hand and guarantees and splendid showing. He wants in particular all the good young cattle that can be had and urges every farmer to cooperate with him in this type.

P. P. Sullivan, superintendent of swine division, is taking care that his division is above the usual fine display.

C. M. Jackson, superintendent of sheep, which is a practically new addition to the show, will have a fine exhibit of the woolly money makers and show what can be made at the sheep game on small irrigated ranches.

Dr. Bletski, superintendent of

poultry, expects approximately 100 exhibits. He finds great interest in the hen and she will cackle the tune of profit in eggs and show she is in natural habitation all colors and sizes.

Jens Skovbo, the honey superintendent, will prove that Hermiston is the sweetest town in the Pacific northwest. Mr. Skovbo is the head of the state association and he knows that in this section the bee is at his best and the exhibit will prove it to all who come.

H. K. Dean, superintendent of farm products, will have one of the most popular points of interest about this time of the year when everybody is looking for something right to put in the winter cellar. Farm products are new in the show and this time it would pay every farmer in the county to see Mr. Dean's department.

The boys and girls clubs will have full exhibit from the sewing club, the poultry club, the Jersey calf club, the Holstein calf club, the Poland China club, the Duroc Jersey club, the All Pigs club and there will be some real competition among the embryonic farmers who are getting training so valuable to them in future agriculture.

The board of directors say to take off your working harness and leave behind your daily cares and have a good time. The show has risen to what it ought to be and it needs the smiling faces and general interest of those to whom its purpose is to aid and whose general welfare it will benefit.

Prizes and Medals for Essay

The Oregon Historical Society has selected "The Hudson's Bay Company and the Oregon Country" as the subject for the 1925 C. C. Beekman history prizes and medals. The prizes are four in number, viz., first, sixty dollars; second, fifty dollars; third, forty dollars; and fourth thirty dollars; and will be awarded for the best four original essays on the above named subject written and submitted by girls or boys over fifteen years of age and under eighteen years, attending any public or private school, academy, seminary, college, university or other educational institution within the state of Oregon. Each of the four prize winners will also receive a handsome bronze medal.

The conditions governing the competition are as follows:

- (1) The essay submitted in competition must not exceed two thousand words in length.
- (2) The essay may be in hand writing or in typewritten form, preferably upon paper of commercial letter size, either ruled or unruled, the several sheets being numbered consecutively and written on one side only, with blank space of about one and one-quarter inches at top and left-hand margins.
- (3) The essay shall be accompanied by a separate sheet containing the name and postoffice address of the writer, the date of his or her birth, and the name of the school attended.
- (4) There shall also be delivered with the essay a certificate signed by a teacher or instructor of the educational institution attended, stating that the writer of the essay is a pupil or student attending the same.
- (5) In order to be considered in competition the essay must be delivered by mail or in person to the Oregon Historical Society, Public Auditorium, 253 Market street, Portland, Oregon, not later than March 1, 1925.
- (6) All essays submitted in competition will be numbered and submitted, without the names of the writers and other identifying marks, to three judges selected by the undersigned committee.
- (7) All competitive essays will be judged according to their general merit and excellence; but the judges will also take into consideration, in passing thereon, neatness of manuscript, accurate orthography, correct grammar and composition, and purity and clarity of diction.

In writing to the Oregon state library students should state the information desired and not merely confine requests to some particular book or books sought, thereby enabling the state library to substitute other material in case any book requested is not available.
