

CITY IRRIGATION WATER ASSESSMENT FOR YEAR 1928 DISTRICT NO. 1

Notice is hereby given that in accordance with Ordinance No. 76, as amended by Ordinance No. 122 and 125 of the City of Hermiston, an assessment has been levied by the City Council upon the following lots and parcels of land in the irrigation district established by said Ordinance No. 76 and amended by Ordinances No. 122 and 125, for the purpose of collecting a special improvement assessment to pay for the cost of water for irrigation and delivery of the the NW 1/4 SW 1/4 Section 11 and the NE 1/4 SE 1/4 of Section 10, both in Township 4 N. R. 28 E. W. M., and constructing and maintaining an irrigation system therefor.

The total amount of the assessment in said irrigation district is \$1,041.31.

The contract price to be paid the Hermiston Irrigation District for water for the irrigation in said district is \$1.50 per acre for two acre feet and 50 cents per acre foot for all water in excess of two acre feet.

The assessment assessment is now due and payable at the office of the City Recorder and if not paid by May 10, 1928, the same shall become delinquent and shall bear interest from said date at the legal rate.

Notice is hereby given that in accordance with Ordinance No. 96, as amended by Ordinance No. 126 of the City of Hermiston an assessment has been levied by the City Council upon the following lots and parcels of land in the irrigation district established by said Ordinance No. 126 for the purpose of collecting a special improvement assessment to pay the cost of water for irrigation and delivery of same for the NW 1/4 SW 1/4 of Section 11, Tp. 4 N. R. 28 E. W. M., excepting therefrom Block 7, lots 11 to 16 inclusive in Block 8, Block 11, and lots 4 to 7 inclusive in Block 12 of Newport's addition to the City of Hermiston, the land embraced in the irrigation assessment district provided for in said Ordinance No. 96 and constructing and maintaining an irrigation system therefor.

The total amount of the assessment in said irrigation district is \$630.29.

The contract price to be paid the U. S. government for construction charge is \$131.04 and the price to be paid to the Hermiston Irrigation District for Operation and Maintenance charge is \$74.10.
