**ADVERTISING BUDGETS
 FOUND LOW IN OREGON
 Less Money Spent in State for Advertising Than in Most Other Districts.**

Contrary to some opinion, advertising costs to merchants of Oregon constitute but a small fraction of total selling costs, according to the report of "Operating Costs in Retail Merchandising" just published by the extension service of the state college. The bulletin was prepared under the direction of the school of commerce and contains reports presented to the Oregon Retail Merchants association in convention at Corvallis last February.

Of the six merchandising groups from which data were gathered, the department stores were found to devote the greatest amount of advertising, which was 3.32 per cent out of a total operating expense of 23.79 per cent. At the other extreme the general stores were found to use only .45 per cent out of a total of 18.23 per cent.

Furniture stores report an average of 1.74 per cent of a total expense of 28.92 per cent used in advertising, while grocery stores averaged a mere .50 per cent in a total of 12.88. Hardware stores also devoted a comparatively small budget to advertising, the total being .73 per cent in a total of 22.05 per cent. Drug stores were about the same with 1 per cent devoted to advertising from a total of 27.06 per cent.

In general the Oregon figures for advertising were lower than in other surveys throughout the country with which comparisons were made. Exceptions were that department stores here spent about a third more for advertising than those in an extensive survey made by Harvard university, and that grocery stores here, even at their low figures, exceeded the stores in Nebraska. General stores in the Harvard survey devoted four times as much to advertising.

The bulletins may be obtained free from the extension service. Some are being used by merchants to compare their own costs with those of others.

**SIGNUP OF DAIRYMEN FOR
 ABORTION TESTS UNDER WAY**

An effort to secure a signup of 90 per cent of the cows on the project for periodic testing for infectious abortion is being made as a result of a decision reached last Friday night at a meeting of the executive committee of the Umatilla Project Farm

Bureau. In the past there has sometimes been insufficient time at the disposal of the tester to conduct the test of all cows entered, and the decision to try to secure a 90 per cent signup was made after Dr. Simms had told dairymen on his latest visit that if enough interest is felt in the work to sign up nine-tenths of the cows, time will be found to give the service without charge to dairy men.

Germany Accepts Anti-War Treaty.

Washington, D. C.—Germany's reply to Secretary Kellogg's last note transmitting a revised draft of his proposed treaty renunciation of war as instrument of national policy was received at the state department. The German reply was the first to be received by Secretary Kellogg in response to his note of June 23 to the 14 governments invited to become original signatories to the treaty.

Railroads to Own Express Business.

New York.—The American railroads announced definite plans for taking over the country's express business. Presidents of four of the larger railroads were appointed agents with broad powers to acquire either the assets and property of the American Railway Express company, or its stock and to organize a new corporation, the Railway Express Agency, Inc.

**Big Python Resented
 Invasion of Poacher**

**Wrong Beliefs About
 Exercise and Heart**

The old belief that the heart increased in size according to the increased amount of work it is called upon to perform is a myth, Dr. Matthias J. Selfert, Chicago, says in a study of the effect of exercise upon the heart, prepared for the Gorgas Memorial Institute at Kansas City.

If an athlete's heart increases in size it is not because of the exercise he has performed, but because there was something fundamentally wrong with it to begin with Doctor Selfert declares.

"It is now found," he says, "that the predisposition of the heart to enlargement is the result of infectious diseases, such as scarlet fever, pneumonia, rheumatism and too strenuous exercise in youth, as well as to psychic traumas.

"Exercise for pleasure causes no enlargement of the heart, but on the contrary produces a strengthening of the whole body and, normally, even a smaller heart."

One little boy, age six, was asked the hypothetical question:
