Has Prohibition destroyed Personal Liberty?

"There are always two sides to any question. But on the subject of personal liberty the average wet completely loses his sense of perspective. After all, what is personal liberty? Is it the right to do whatever one wants to do whenever one wants to do it? If it is, then the people of this country have deluded themselves badly in proclaiming their country the land of the free. For personal liberty was long ago taken from the man who would willfully commit murder, or the one who found it to his liking to earn a livelihood by his gun, or the one who piled the matter of personal viewpoint. The real reason for prohibition is not that imbibing alcohol affects the drinker himself. That particular side of the question is purely personal with the individual. But when the drinker trespasses upon the liberty of others, that is something different. It is an inescapable characteristic of drinking that the drinker does trespass upon the rights of his fellow citizens—so considerably and in so many ways that he seriously interferes not only with personal liberty but also personal life and welfare. In the final analysis, the safe-guarding of personal liberty narrows itself down to protecting the rights of the majority as opposed to the desires of the minority. A legal liquor traffic had so long and so consistently encroached upon the rights of the majority in this country that that majority finally sought and found rightful protection of its liberty through the adoption of the Eighteenth Amendment to the Constitution. Personal Liberty? The ones who shout the loudest for personal liberty are, in fact, enjoying personal liberty to an extent unknown just a few years ago, and prohibition has been a prime factor in bringing about this new personal liberty.

Within the last ten years we have become the richest nation the world has ever known. Prohibition has contributed in a very definite way to this unparalleled advancement. It has done so by increasing the producing power of the individual, hence of the nation. One of the serious problems in industry before prohibition was the absence of employes

following pay days. Today the "Blue Monday" absentee—victims of week end drinking—are to all practical purposes a thing of the past. Likewise, the daily drinking recess periods, so common at one time, remain only in memory. Hence, today, man power is more steadily and more efficiently applied, for cleaner living means better health and better health means better workmanship, steadier and more accurate, more intelligent applying of brain power. The wage earner today is worth more in wages and therefore receives higher wages. His earnings are spent for useful things impossible to consider before, when a substantial share of his earnings went for drink. Personal liberty? How about the wives and children—millions of them—who suffered for food and shelter and clothing because the family income was squandered at the bar to satisfy the cravings of a drunken husband and father. Those wives and children have found real liberty since prohibition. Today the typical working family enjoys a comfortable home, radio, vacuum cleaner, auto, electric washer and attractive furnishings unknown before. Personal liberty? There's a different angle of personal liberty to consider nowadays with those 26 1/2 million motor vehicles on the roadways of America. Even the most ardent advocate of liquor flinches at the menace of the drunken driver. Liquor and gasoline don't mix. This is the age of speed—and speed is typi-

cally American. It is not only logical but inevitable that the United States—pace maker in this age of motor advancement—should have led the world in adopting national prohibition. How cheaply we would hold human life if we legalized the sale of alcoholic beverages! Legalized liquor selling in any form would place constant temptation before the motorist. Such a condition is unthinkable, and finally, on the subject of personal liberty, suppose we get right down to the heart of the whole matter—alcohol itself. The greatest destroyer of personal liberty man has ever known is found in the underlying reason for the 18th Amendment, which is alcohol. A drug, a narcotic of the same family as either, chloroform, a dangerous habit forming poison, alcohol grips its victim relentlessly, weakens the moral fiber, impairs mental and physical fitness, interferes with enjoyment of the finer things of life, destroys personal liberty in a manner peculiar to itself! Personal liberty? That is the strongest argument in favor of prohibition. For real personal liberty, would you choose the stein and goblet of the European? Or the modern home life, the higher wages, the advanced living standards of the United States—the accelerator, steering wheel and 662,435 miles of hard surfaced highways that give to every American the boundless freedom of this whole great continent. Information and Rules for the NINETEENTH ANNUAL UMATILLA PROJECT FAIR OCTOBER 9 and 10

INFORMATION TO EXHIBITORS

The Umatilla Project Fair is held primarily for the purpose of encouraging more profitable agriculture on the Greater Umatilla Project. In distributing the premium money the directors have emphasized the products of most importance. No entry fee is charged. The Association will provide alfalfa hay and bedding free of charge, the exhibitor to furnish any other feed desired. Reliable men will be in charge of the stables at all times and will feed for exhibitors on request. Pens are about 6 by 8 feet. The Association will have experienced milkers, who, upon request of the owners, will milk all cows while on the grounds, free of charge. Premiums — Premiums will be designated by ribbons: Purple and Blue, Grand Champions; Purple, Championship; Blue, first; Red, second; White, third. Awards will be paid by check and mailed to the exhibitors address not later than November 1, 1931 Board of Directors—J. Jendrzewski, President; Harry Kelley, Secretary; L. C. Dyer, Wm. Logan, C. A. Lynch, Lyle Tilden.

RULES OF ENTRY

Rule 1. All applicants for entry must be made on printed forms and in accordance with instructions on same. These forms, properly signed, are to be filed in the office of the Secretary of Umatilla Project Fair Association on or before October 8, at 4:00 p. m., at which time entries close. In all cases the right is reserved to reject entirely or accept conditionally any entry or application for entry. Rule 2. All stock entries must be on the grounds by 1:00 p. m. October 8. Rule 3. To be eligible for competition, animals must be the bona fide property of exhibitors. Rule 4. In all contests of registered stock the papers of registration must be filed with the Secretary not later than 6:00 p. m. October 8, if so requested. Rule 5. Each exhibitor or assistant must be in charge of his entry during the hours of judging and demonstration under authority of the judges. Rule 6. Exhibitors of livestock must report to the Superintendent in charge at 9:00 o'clock a. m. for orders. They must inform themselves from the Superintendent of the division when their stock will be judged. Stock must be in the show ring promptly after being called, with proper entry tag attached. Rule 7. All exhibitors of livestock shall be required to parade their stock when requested by the management. An exhibitor who fails or refuses to comply with Rule 5 and 7 forfeits all claim upon the Board. Rule 8. If any disrespect is shown to any award

or to the awarding committee, by the exhibitor or his agent, he shall forfeit all awards made to him, and the officers in charge shall report the same to the Board at its first subsequent meeting. Should a premium be found by the board to have been obtained by false evidence, or misrepresentation, or a violation of any of the above rules, the money will be withheld by the secretary.

Rule 9. Men in charge of the stock are strictly prohibited from making any remarks regarding the stock unless information is requested of them by the Judges or Superintendents. Attendants infringing on this rule will be excluded from the ring by the Superintendents.

Rule 10. Exhibitors will at all times give the necessary and personal attention to whatever they may have on exhibition and at the close of the show must take entire charge of their property and remove promptly. Every exhibitor will be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, or arising from, any animal exhibited by him, and shall indemnify the Association against all legal or other proceedings in regard thereto. The Umatilla Project Fair Association will take every precaution in its power for the safe preservation of stock and articles on exhibit and all property of every character entered for competition or display, or for any other purpose, or being anywhere on the grounds, shall be subject to the control of the Umatilla Project Fair Association, but in no case will the Umatilla Project Fair Association be responsible in any way for any loss, damage or injury of any character to any such property while the same is on the grounds, or at any time or place. If the property owners or others interested in property desire protection against loss or damage or injury from fire or other causes, they must make their arrangements therefor. No Officer, Trustee, Superintendent or employee of the Umatilla Project Fair Association has authority to suspend or change this rule.

Rule 11. No animal or article deemed unworthy shall be awarded a premium, and no premium shall be awarded merely because there is no competition. If the article is not worthy of the first premium, it may be awarded a lesser premium, and where there is but a single exhibitor in any class, the judge may award but one premium.

Rule 12. No exhibit may be removed from the fair grounds before 8:00 p. m., Saturday, without a release from the Secretary.

Rule 13. No female dairy animal of breeding age which has not been tested for and found free from infectious abortion will be admitted to the show grounds.

Rule 14. No bull over one year old shall be removed from stalls for any purpose, unless handled by two men.
