made mandatory, and it shall be the duty of such several old age pension commissioners to organize as such, hear applications within a reasonable time, appropriate the necessary money to carry this act into effect, and otherwise to comply with the provisions of this act.

This means that sufficient taxes would have to be levied to pay \$30 per month to all those who are dependent, or sufficient amount to create \$30 per month were they partially dependent.

Dr. Temple estimates the cost to Oregon, were this act to become a law, would aggregate \$2,000,000. New Jersey with such a law provides \$3,675,000 for the year 1932. Oregon is already carrying more taxes than the state should and the people are groaning under the tremendous burden.

The Dr. favors, however, an old pension law, but the revenue should be provided by the earnings of capital and labor, and when gainfully employed, a certain ratio to be set aside for the creation of this fund.

sheriff's office, the appointment of the collector to be made by the county court and under their direct supervision. No private concern or public corporation would entrust the collection of nearly \$1,000,000 to one unskilled in making such collections at the time when due.

Our treasuries are now depleted by reason of taxes not collected when due. An active, energetic tax collector could do much to relieve the situation, and our teachers' warrants would not be selling below par were such a law in effect.

He advocates the continued 8% interest on delinquent taxes, but recommends a penalty of 2% for taxes that are not paid when due. State income tax provide 5% penalty and the federal tax carries similar penalty.

Important legislation confronts the next legislature, it behooves Umatilla county people to elect representatives who have given the subject of legislation and taxation careful study. We cannot reduce taxes in the state by lowering the values, since there is no state tax to pay, hence equitable value of property is important. The only way to reduce taxes is to spend less.—(Paid adv.)
