WILL ROGERS, AMBASSADOR OF HUMOR TO ALL NATIONS.

"Ambassador Bill," Will Rogers' latest picture under the Fox banner, is regarded by some people as an actual historical document of some importance. This, not because of anything dealt with in the plot, though this, too, has a timely interest; but because of the revelations it contains of the star's methods in diplomacy.

As an unofficial diplomat, the ace "trouble man" of Washington, Rogers has brought a note into international relations that is unique in history. Not sent directly to negotiate treaties, or to prevent the severance of relations. He yet accompanies the accredited diplomat to prepare the soil, as it were, and make sure that the work is done against a friendly background. There is little doubt that some of his work in this regard has been invaluable. That in Mexico, for instance, will be particularly remembered.

So often in the past the course of nations, and of history, has been turned by the human equation. And this is just as true today as it ever was. It is fortunate, therefore, when there appears a man of the calibre of Rogers, who has the ability to make that element operate for the best, rather than the worst, that is in it.

In "Ambassador Bill," we see "him as the rough, but truly wise, American Ambassador who untangles the scrambled politics and royal loves of a glamorous little kingdom ruled by a boy king. Shocking the snobbish hangers-on of the court by his total disregard for etiquette, he endears himself to the real human beings beneath the ermine. Rogers it will be remembered, has actually done this in real life, and knows whereof he speaks.

Rogers, it seems, is one of those rare individuals who are able to go through life as though the false-fronts of other people did not exist. And what is rarer still, he is able to do this without giving offense to others.

This, of course, is only because the man is not limited by his wisecracks. One invariably feels a depth of wisdom and universal sympathy beneath the most biting phrase.

This humane quality is said to reach its full flavor in "Ambassador Bill" which opens Sunday and Monday at the Oasis theatre. That this is so should occasion no surprise, considering the theme. In it, Will Rogers, the star, is simply reliving the life that has made Will Rogers, the plain citizen, so famous. Sam Taylor, is credited with a capable directional job in this picture, and the supporting cast is also said to have reflected the star's enthusiasm. This includes Marguerite Churchill, Greta Nissen, Tad Alexander, Gustav von Seyffertitz and Ray Milland.

FEWER CHICKS ON FARMS; MORE FRUIT IS EXPORTED.

Fewer hens and chicks than usual on farms in the United States is indicated by a report on the agricultural situation just released by the Oregon agricultural extension service. The number of hens on farms on May 1 was estimated at 2 per cent less than a year previous, the smallest number in eight years.

About the same number of chicks of this year's hatching were reported in farm flocks on May 1 as a year before, but 10 per cent fewer than the 5-year average on that date. The report said that 7.6 per cent fewer chicks were hatched by commercial hatcheries during April this year than in 1931 in the whole country and that orders booked for May delivery and later were 8.3 per cent less than a year ago.

On the Pacific coast, April hatchings by commercial hatcheries ran 24.6 per cent behind last year and bookings for May and later were short 29.4 per cent. The commercial hatchery chick output has fallen behind 1931 throughout the season in the western states, and is also somewhat short in the eastern part of the country. Information on the volume of farm hatchings is incomplete but some observers think that enough chicks have been produced from this source to offset in part at least the reduction in commercial chicks.

A 12-ton anchor is being constructed of railroad iron and concrete at Bandon by a government crew. It is to be used as a tail hold for the bucket dredging rig when it works on the bar.

The Redmond grade school budget for next year will be submitted to voters June 20. The total of the budget is \$27,931, which is \$8332 less than last year, a reduction of about 10 per cent.

Annie Young Chief, 88, well-known Indian woman on the Umatilla reservation, died in a Pendleton hospital last week following a stroke of paralysis. Her Indian name was "Ta-de-le-ka-tas-an-mi."

The Silverton Garden club won first prize in the annual Willamette valley flour show at Salem recently, in the garden club section. Corvallis was awarded second place and Albany third.

The sum of \$12,324, representing a 6 per cent dividend, is being paid out by the receiver of the First National bank of Redmond. This is the second dividend paid, making a total of 21 per cent.

In an effort to hasten a court decision on the high school tuition law representatives of seven high schools in Marion county have decided to employ two special attorneys to assist the district attorney.

Malheur county will seek the cooperation of Idaho in an effort to wipe out a 300-acre field of noxious White Top weed on Succor creek, in the Jordan valley country, which lies in both Idaho and Oregon.

Mrs. E. A. Wells of Redmond possesses an old melodeon which was made in 1836, the instrument that preceded the organ, and was handed down from Rosella Isabel Oatthout, who was the first owner of the melodeon.

Mrs. George Harper claims to hold the record as the most isolated housewife in the United States. She lives with her husband on a 900-acre ranch in southern Malheur county, 31 miles from the Nevada border. Theirs is the only inhabited ranch in the 70-mile stretch of isolated territory between the Owyhee river and McDermitt, Nev.

The Dalen Manufacturing company of Bandon has resumed full operations, having been running on a part-time schedule since the first of the year. It is thought the factory will run continuously for an indefinite period. The Moore Mill & Lumber company, also of that city, is employing its full force, working on an average of four days a week.

Consolidation of election precincts to reduce the cost of elections is being considered by the Linn county court. Costs this year ranged from 25 cents a vote in the large Albany precincts to \$1.60 in the smallest district of the county.

"GROW YOUR MEAT" BEING SUGGESTED BY SPECIALIST.

While much has been said and written about growing next winter's food in this summer's gardens, an equally attractive opportunity exists this year for getting next winter's meat supply at the most reasonable price in decades, says H. A. Lindgren, livestock specialist of the state college extension service.

"Hogs are cheap and so is grain," says Lindgren. "A weaner pig fed from now till fall on such feeds as are available on the farm can be made into 125 to 150 pounds of meat for next winter's use. It can be cured as hams and bacon, made into sausage, dry salted, or canned."

"Pigs can be fattened on pasture with a little grain. Table scraps also make good hog feed. Under conditions such as we are now experiencing one can even raise a hog in a small pen, supplying it with green grass, table scraps, and a few pounds of grain daily."

"Grass is plentiful at this time. Why not fatten a calf, cow, or steer on grass and corn, and can the product for next winter's use? Beef put up in that form is excellent and will fit in well with the garden products now being raised by many families in our state."

"Mutton and lamb can be cured and smoked in much the same way that we prepare hams and bacon. The product is delicious and will add a variety which will be greatly appreciated."

Federal bulletins on methods of preparing these products are available through the local county agricultural agent's office without cost. Where no agent is employed one may write the animal husbandry department of Oregon State college, Corvallis for the bulletins.
