Sights Seen on Trip Related

(Continued from Page One)

To crowd in four days what there is to see in Chicago was quite a difficult problem. It will take several weeks and months to recall the many things we saw, but I will try to mention a few of the high spots of interest.

On our arrival Thursday, we visited the great Lincoln Park along Michigan Lake, only one of the 143 Chicago parks. Here all the wild animals, birds and fish of every size, shape and description could be seen. During my brothers' three years stay in Chicago he had learned to know the streets of the city quite well, so for several hours that evening we roiled along with the heavy traffic that goes on 24-hours every day.

Among other things Friday morning we visited the huge Tribune Tower, which houses the largest newspaper in the world. The Sunday edition of the Chicago Tribune has a circulation of over a million. After floating to the top in an elevator, 35 stories high, we viewed the city of Chicago from on top—and on top it was. Looking to the east we could see beautiful Lake Michigan, with waves like those of the ocean, while in the other directions many skyscrapers towered majestically. In the afternoon we visited the Moody Bible Institute in which my brother is a student. That evening we had the privilege of accompanying a group of Institute students to witness the Armour Hour National Broadcast in the Merchandise Mart, world's largest office building. Here we were in the same room from which music was sent all over the U. S., while Mrs. Edna Kellogg, noted soprano, the Armour hour quartet and orchestra, presented the program over the air.

An elevated railroad took us Saturday morning to the Chicago Stock Yards, the world's greatest stock yards. It took almost three hours to go through the different departments, walking a distance of a mile and a half. Since our time was getting limited, we had to make Saturday afternoon count, taking in a little of everything. We visited the Planetarium and the Field Museum of Natural History, which would take months alone to see everything. These two buildings will also be included in the World's Fair buildings, which is to be held in 1933, from the first of June to December first, five months. We also visited some of the other buildings already erected for the big occasion. Preparation is going along fast—depression or no depression. One thing that surprised us all was that only a general admission of 50c will be charged, which will admit one to all of these large buildings.

Saturday night came the biggest treat of all—attending the Chicago Grand Music Festival. Just about 125,000 persons, a record crowd, sat under the stars in the arena of Soldier's field to enjoy the simple pleasures of an old fashioned community sing. It would make a long story alone to tell of that evening's festivity. Thirty-seven drum corps competed for honors; 2000 hands men; a male chorus of 2000 negro voices; ladies chorus of 1500 voices; and fireworks, made the evening one of the most colorful I have ever experienced. Seeing such a vast crowd of 125,000 alone was worth the 25c general admission price, and then coming out alive in a traffic jam of 10,000 cars that moved along at 45 miles an hour. Such a crowd could be divided into 20 cities the size of Pendleton. Electrical amplification was used in broadcasting to the large arena and every word was heard distinctly in every corner of the stadium.

Sunday was also a busy day for us. In the evening we attended the Moody Memorial church, often called the "million dollar church." As far as the outward appearance of the depression was concerned, one wouldn't really say that a depression was on—or already over. Everything seemed to be working or moving on as they had in the past, although it was said that almost all but a

dozen or so of the large sky-scrapers and buildings were in receiver's hands. Of course, the need of the poor would not be seen in the hustling part of the city either. The depression was also more noticeable in most smaller cities seen on the trip, where empty business houses were often lined along the streets. One thing was sure, no matter where one came, in the midst of desert lands or in the cities, the people all knew of hard times.

Monday morning we started on our homeward trail, going across Illinois into Iowa, through Dubuque, Waterloo, Ft. Dodge and into the little city of Sac City for the first stop. The next morning we were stopped once and slowed up another time just before we got to Sioux City, Iowa, by the Farmers' Holiday strike. Telephone poles and lumber was piled along the highway while groups of men, young and old, were lined up, ready for any necessary action. Crossing the Missouri river at Sioux City, we again drove across the state of Nebraska. Highway 20 is almost parallel to Highway 30, but about 50 to 100 miles further north. Leaving Valentine, Nebraska, Wednesday morning, we arrived at Riverton, Wyoming, for the night. More excitement awaited us Thursday when we left highway 20

to see in the Rocky Mountains just south of Yellowstone Park. No sooner had we crossed this range than we came face to face with the Teton range, crossing at the famous Teton Pass. This bit of drive won't be soon forgotten as one could look down thousands of feet with only a narrow road ahead. After crossing this range we turned southwest to Praterello, Idaho, where we again came to Highway 30, arriving at Rupert for the last night on the trip. We drove into Hermiston Friday night, thankful for such a safe and interesting trip. We were also glad to rest in the three hours lost on our trip to the east. My folks with my brother continued home to Dallas, Oregon, Saturday morning.

America Owes W.C.T.U. Much

The Women's Christian Temperance Union today closes a week's convention. Seattle is proud to have been host to the delegates attracted by the convention.

The close contact with this organization of women has been in many ways inspirational. The presence of such a band of women is beneficial to Seattle or any other city. Motivated by the highest principles, the visitors leave Seattle food for serious thought. And, incidentally, they leave behind no broken furniture.

The W. C. T. U. claims to have in membership or close sympathy one million voters. It all started after a crusade on the saloon in Ohio in 1870-73. The fight was "to protect the home against liquor and other vices." Frances E. Willard was the leader then, and later she became president of the society which the Ohio struggle brought to life—the W. C. T. U.

From the start the Union made war on the saloon by frontal attack and by teaching, in the schools and homes, the evil effect of liquor on the body and mind.

Its battle cry was and is to neither ask nor give quarter. Yet its members always have been gentle women, refined and kindly. Now and then one of the Carrie Nation type has appeared. But in the main these women remind you of the good souls you have known since childhood.

The women's work naturally has led them into politics but they have kept clean hands. Many of their leaders have developed keen political minds. Many a politician without knowing it owes his downfall to the W. C. T. U.

Surrender, retreat compromise are three words not in their vocabulary. They fight with patience, persistence and prayer. They have won their chief objective—abolition of the saloon. Their problem now is to hold the ground. They insist they will find a way. They say a rum shop by another name would make you just as drunk. Often misunderstood these women press on.

They do not work for pay or for glory but for the cause. As many see it they take life too seriously. Their answer is they have serious business on hand.

Come what will in the control of liquor, the W. C. T. U. has floored the saloon and its attendant pernicious influences. The saloon is down and out and it will stay down. The credit must go to the W. C. T. U. What American organization has more to its credit?—Seattle Star.
